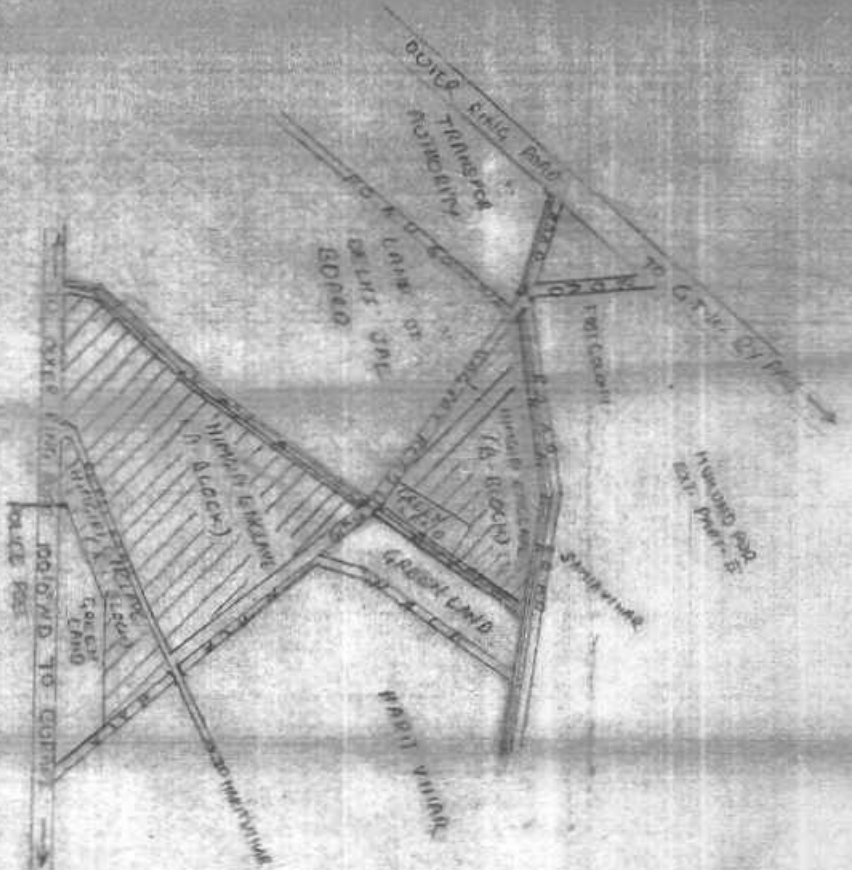

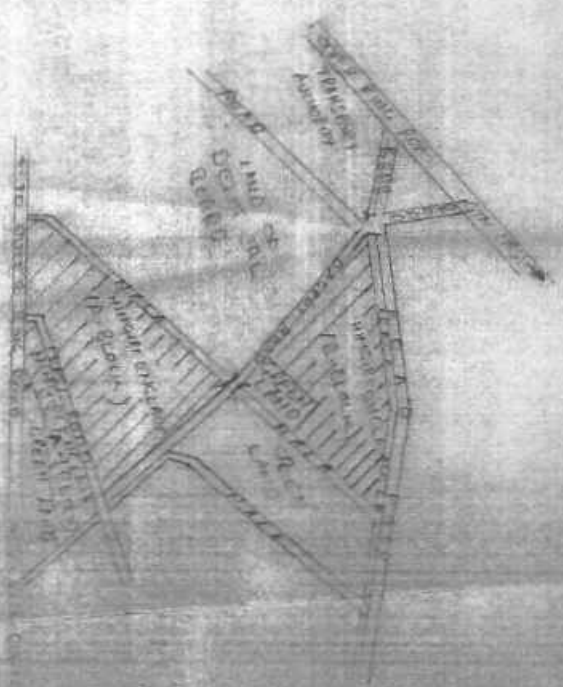

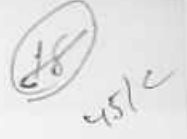

(c) **Adjourned Meetings**

If the President adjourns a meeting to a fixed time and date at the meeting, no fresh notice for such adjourned meeting is necessary, but an intimation may be sent by the General Secretary to the members who are absent.

(f) **Notice for Resolution**

Written notice of any resolution or amendments to aims and objects, bye-laws and rules to be moved at an Annual General Meeting of the members shall reach General Secretary 15 days before the date fixed for the meeting duly signed by the mover of the resolution.

(g) **Accounts**

All monies of the Association shall be paid into the Association's account in a nationalised Bank as approved by the Executive Committee and the account shall be operated jointly by any two of President, Secretary and Treasurer.

(h) **Auditing**

2. Meetings

General Body Meeting

- (a) A Meetings of the General Council shall be either an ordinary meeting or a special meeting as the case may be.

Ordinary Meeting

There shall be atleast one Ordinary Meeting every year. The Annual General Meeting of the members shall be held within 60 days after the close of the financial year.

Special Meeting

Executive Committee shall have power to convene Special Meetings. A Special Meeting of the members shall be convened within 30 days, if at least 1/3 of the members send written requisition alongwith the agenda for such a meeting to the General Secretary.

- (b) Executive Committee Meetings

There shall be at least one meeting of the Executive Committee in one month at which the previous months report shall presented and passed.

- (c) Notice and agenda for Meetings

For meeting of the General Body at least fifteen clear day's notice shall be given alongwith the agenda for such meeting, venue, date and time of the meeting and for the Executive Committee 2 days notice with particulars. Emergent meeting of the Executive Committee / Branch Committee shall be convened with a shorter notice not less than 12 hours.

- (d) Quorum for the Meetings

The quorum for all meetings, i.e. General Body shall be 1/4 and Executive Committee shall be 1/2.

If, however, two consecutive meetings of the Executive Committee could not be held due to lack of quorum, the members present at the next meetings shall constitute the quorum and decision taken at such meetings shall be in order.

- (c) Authority to conduct all the correspondence of the Association, maintain all records including member's register, issue notice for shall meetings, drafting reports for presentation of the Executive Committee and General Council. The draft of the report to be presented to the General Council shall be subject to the approval of the Executive Committee before presented to the General Council.
- (d) Responsibility for submitting prescribed statements, return and other papers before the Register of Societies and such authorities.
- (e) Authority to keep full and accurate accounts, collect funds, issue receipts, make authorised payments on behalf of the Association.
- (f) Power to be in charge and possession of the premises of the Association and its office with all movable properties in it such as furniture, equipment etc.

4. JOINT SECRETARY

The Joint Secretary (ies) shall help the General Secretary in the day to day functioning of the Association and will also discharge all other duties assigned by the Secretary.

5. CASHIER

The Cashier shall keep the funds of the Association as per the instructions of the Executive Committee.

6. VICE - CASHIER

The Vice Cashier shall assist the Cashier and shall act for him as his absence.

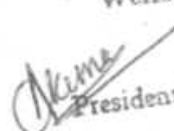
V. GENERAL

12. **Privileges of Members :**

- (a) A Member shall be entitled to a copy of Memorandum of Association and Rules and Regulations of the Association and amendments and alterations for a fee of Rs. 50/-.

13. **Membership Register :**

Executive Committee members shall be elected by the General Council of the Association at its annual general meeting for a period of one year and shall be eligible for re-election after completion of their tenure but not member shall be eligible for holding the same office more than five consecutive terms whether full or part. These office bearers shall not be eligible to hold offices of any other Association of the same type.

General Council

- 1. The General Council shall elect the Executive Committee and the office bearers in its annual general meeting for a period of one year.
- 2. The General Council shall approve the Annual Report and Accounts of the Association and approve Annual Budget.
- 3. The General Council shall give general policy guidelines to the Executive Committee through resolutions.

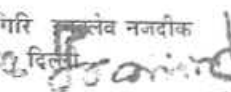
