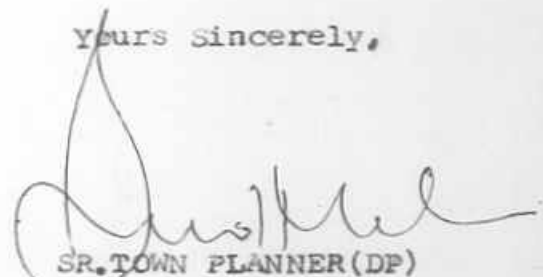

I happen to know Rishi Keshwanand ji and also the Institution for the last many years. This Institution is engaged in the activities for the benefits of poor, old, destitutes, sick, hungry and the needy and are doing self less spiritual and educational activities also. I visited their Ashram recently for laying the foundation stone of Girls Degree College in Hardwar. This land where the Ashram at Narela is situated was duly purchased by them in 1991 and had made some consturctions and the temple in that area.

In this area there are a large number of other religious places like Radha Swami Satsang Sthal, Dada Piru Sadh Smadhi Sthal, Sri Ratenswar Mahadev Mandir Satsang Sthal, Sewa Ashram, Sri Bankey Bihar Mandir, Sri Veshneo Devi Mata Mandir and a Gurdwara also. So it is requested that Nirdhan Niketan Ashram Satsang Sthal may be treated in the same manner as the other Institutions are being treated and no demolition may be carried out.

It appears to be a genuine case and needs your favourable attention. If necessary, the management can come and produce all the documents in this behalf.

The Governing Body, in its meeting, shall form the Branches and/or the Sub-committees all over India and abroad to attain the Aims and objects of the society.

18. ADVISORY BOARD:-

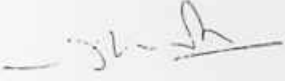

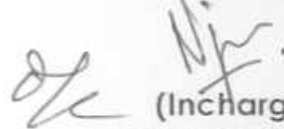

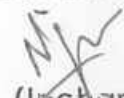
