19. AUDIT:

The account of the society shall be audited atleast once in year by an qualified auditor appointed by the governing body.

20. FINANCIAL YEAR:

The financial year of the society shall start from the 1st day of April to 31st day of March every year.

21. TENURE:

The term of governing body shall be two years.

22. AMENDMENTS:

Any amendment to Memorandum and Rules and regulation will be carried out in accordance with section 12 and 12-A of the S.R. Act of 1860 as applicable to the Union Territory of Delhi. The amendment to the memorandum Rules and Regulation shall be made under this section.

10. SOURCES OF INCOME:

- i) Admission fee.
- ii) Subscription.
- iii) Donations and special contributions. all the income of the society shall be utilized for the fulfilment of its aims & objects of the society.

11. GOVERNING BODY:

The governing body's strength shall not be less than 8 and not more than 21. The members of the governing body shall not hold the office for two years. The meetings of the society as and when necessary for which 15 days clear notice shall be required and quorum shall be 2/3rd. The governing body of the society shall have following powers:-

5. RE-ADMISSION:

In case of a member expelled by the general body the same member can be re-admitted provided the member concerned, pays all dues upto date. The decision of the general body shall be final. This is applicable to clause clause '3' from B' only.

6. GOVERNING BODY:

The Governing body shall consist of all members and office bearers as under :-

7. BANK ACCOUNT:

The Bank account of the society shall be opened in any nationalised or scheduled banks as may be decided by the governing body and shall be operated by the treasurer and any one out of president/General Secretary.

1. MEMBERSHIP:

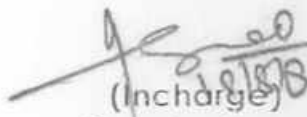
