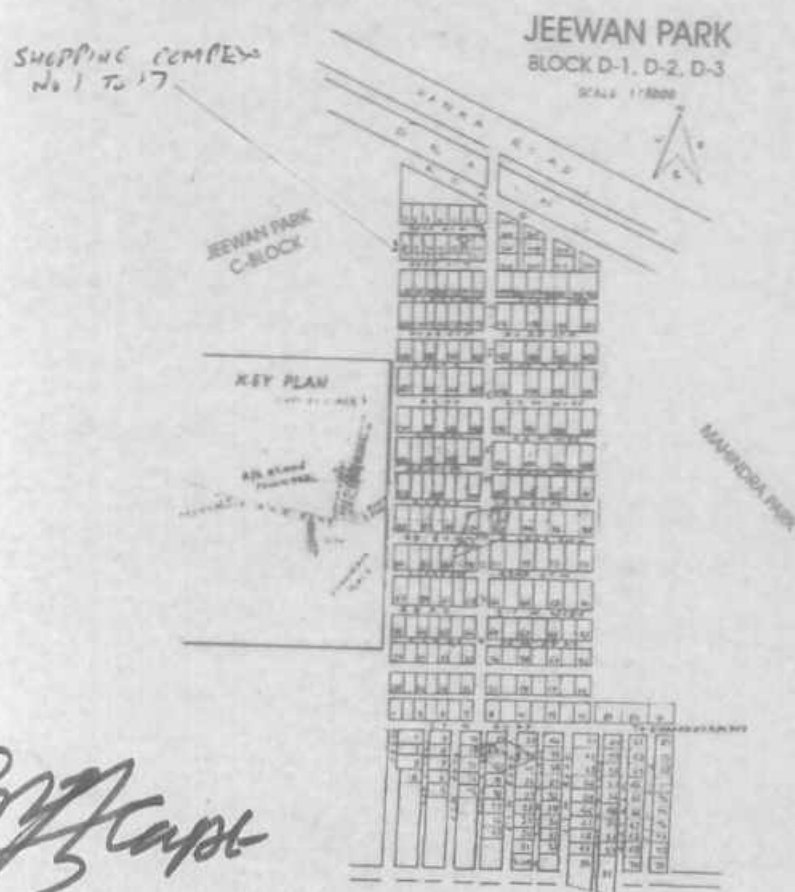

With reference to the advertisement by the Ministry of Urban Development in the leading daily new papers dated 04.11.07 invited fresh application for the regularization of unauthorized colonies in Delhi. I hereby submit the following few lines for your kind consideration.

Applications for regularization of unauthorized colonies in Delhi was first called for by The Ministry of Urban Development in 1999. The Association submitted the same alongwith the required documents on 15.11.1999. After lapse of four years the Ministry has again called for fresh application from the RWAS for the same purpose which was also submitted alongwith 7 sets of required documents on 27.12.04 but no action has been taken on the above documents.

It may please be stated that the U. D. Ministry has once again invited fresh application for the above purpose after four years putting unbearable financial burdon on the RWAS which have meager sources of income. The columns provided in the application form i.e. specially column 5 to 8 demanding names of physical surveyor, Socio Economic Surveyor, Service Engineer, Supervising Engineer and Town Planner etc. are such which involve hiring of services of these officials beyond the means of the R.W.A.S. the RWAS are not financially capable to bear such heavy expenditure of thousands of rupees again and again as the funds are raised by contribution from the members in the absence of any financial grant from any other source.

It is therefore requested that Urban Development Ministry may kindly be directed to suitably review / delete provision of the application form and provide the services of Town Planner Surveyors, Engineers etc. enumerated in the column 5 to 8 of the application form to ease the financial burdon on the RWAS which represent mainly lower middle class of the residents and are hardly able to raise funds every now and then.

Hope you will very kindly extend sympathetic consideration to the above points.

Respected Madam,

With reference to the advertisement by the Ministry of Urban Development in the leading daily new papers dated 04.11.07 invited fresh application for the regularization of unauthorized colonies in Delhi. I hereby submit the following few lines for your kind consideration.

Applications for regularization of unauthorized colonies in Delhi was first called for by The Ministry of Urban Development in 1999. The Association submitted the same alongwith the required documents on 15.11.1999. After lapse of four years the Ministry has again called for fresh application from the RWAS for the same purpose which was also submitted alongwith 7 sets of required documents on 27.12.04 but no action has been taken on the above documents.

It may please be stated that the U. D. Ministry has once again invited fresh application for the above purpose after four years putting unbearable financial burdon on the RWAS which have meager sources of income. The columns provided in the application form i.e. specially column 5 to 8 demanding names of physical surveyor, Socio Economic Surveyor, Service Engineer, Supervising Engineer and Town Planner etc. are such which involve hiring of services of these officials beyond the means of the R.W.A.S. the RWAS are not financially capable to bear such heavy expenditure of thousands of rupees again and again as the funds are raised by contribution from the members in the absence of any financial grant from any other source.

It is therefore requested that Urban Development Ministry may kindly be directed to suitably review / delete provision of the application form and provide the services of Town Planner Surveyors, Engineers etc. enumerated in the column 5 to 8 of the application form to ease the financial burdon on the RWAS which represent mainly lower middle class of the residents and are hardly able to raise funds every now and then.

Hope you will very kindly extend sympathetic consideration to the above points.
