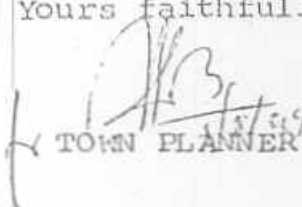
The name of the above mentioned colony has been referred to this Department. for the purpose of regularisation/grant of M.O.C. for electrification.

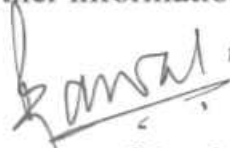

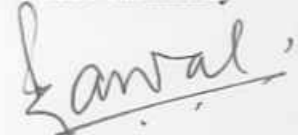

The accounts shall as soon as practicable within the time specified above after the end of the year be audited by an Auditor appointed by the Annual Meeting. Any vacancy occurring in the office of the auditor during the year, shall be filled up by the Executive Council.

RULES AND REGULATIONS OF

1. NAME & OFFICE OF THE SOCIETY:

The name of the society shall be 'PARVATIYA ANCHAL SUDHAR SAMITI' & its Principal office shall be at 104/24, SANT NAGAR DUMARI, DELHI-9.

2. MEMBERS

Admission, qualification, categories etc.

Any person above the age of 18 Years, who has migrated from North East India residing presently at Delhi for a continuous period of more than 3 years shall be eligible for Admission as member of the Parishad on making an application in the prescribed form accompanied by the necessary admission and membership fee, and sponsored by two members of parishad to the President or General Secretary of the Parishad. The application for admission to membership shall be placed before the Executive committee of the Parishad at its next meeting who shall have the right to admit or to reject any such application assigning reasons therefore.

3. SUBSCRIPTION :

Yearly subscription shall be Rs.500.00 per year which shall have to be paid with in 31st May of each year in advance.

4. CEASATION OF MEMBERSHIP

- a) The Office of a member shall fall vacant if he dies: or
- b) He resigns his office and the resignation is accepted:
- c) He is found lunatic or of unsound mind or by reason of age or otherwise becomes Capable to act as a member or
- d) He is convicted of any offence involving moral turpitude; or
- d) He is removed by a resolution of the members passed by a majority of three fourths of the members at the meetings the notice of which contains the proposal of his removal for deliberately causing harm to the Society or placing hindrances causing obstruction in its work or for will fully disobeying any byelaws, rules or customs of the Society ;or
- f) In case he is a primary member and fails to pay the annual subscription with in three months from the due date.



5. RIGHTS & PRIVILEGES OF MEMBERSHIP:
