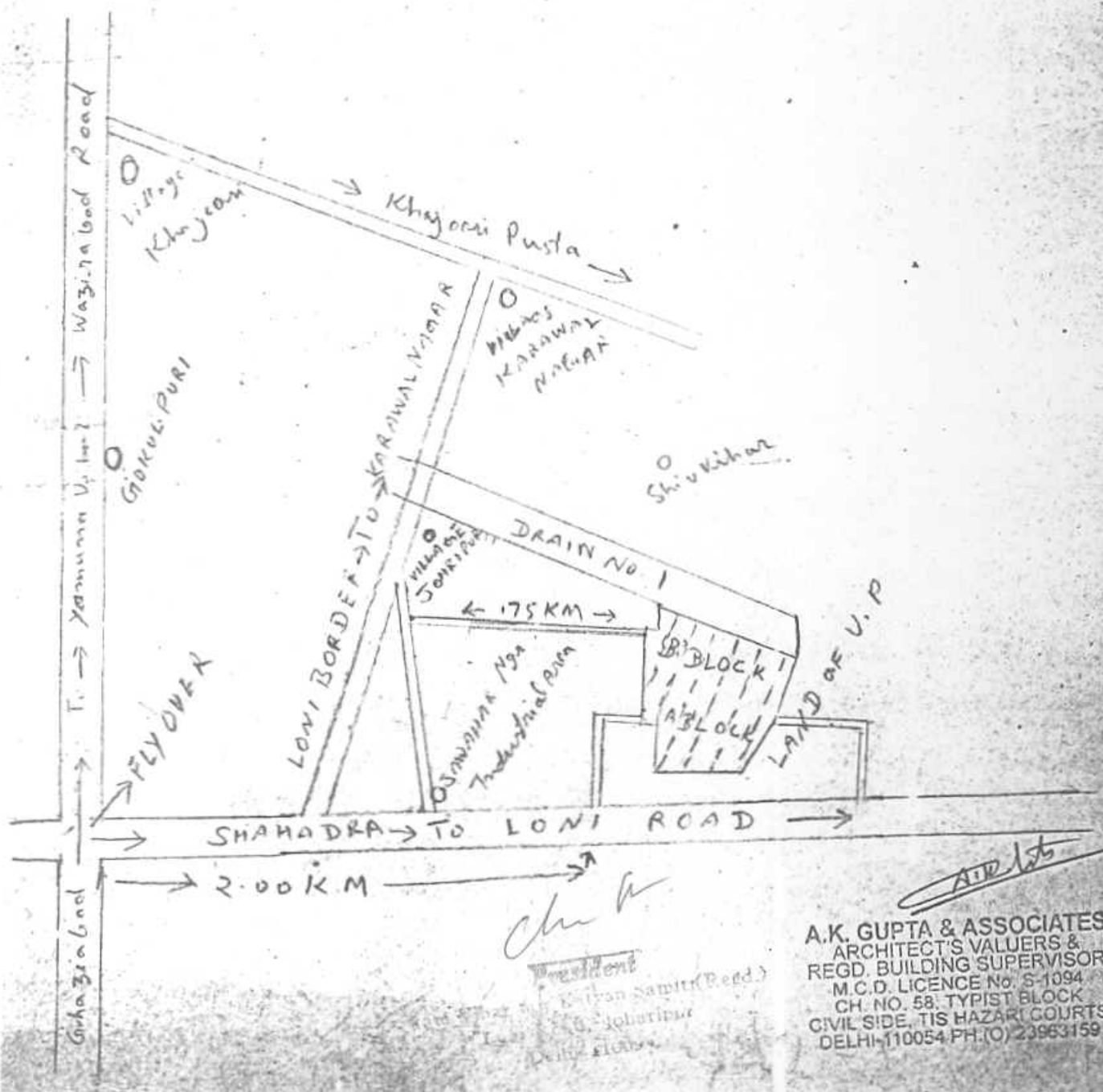
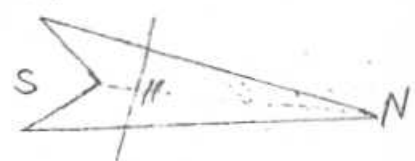


SITE PLAN OF RAM VIHAR COLONY (A & B BLOCK)

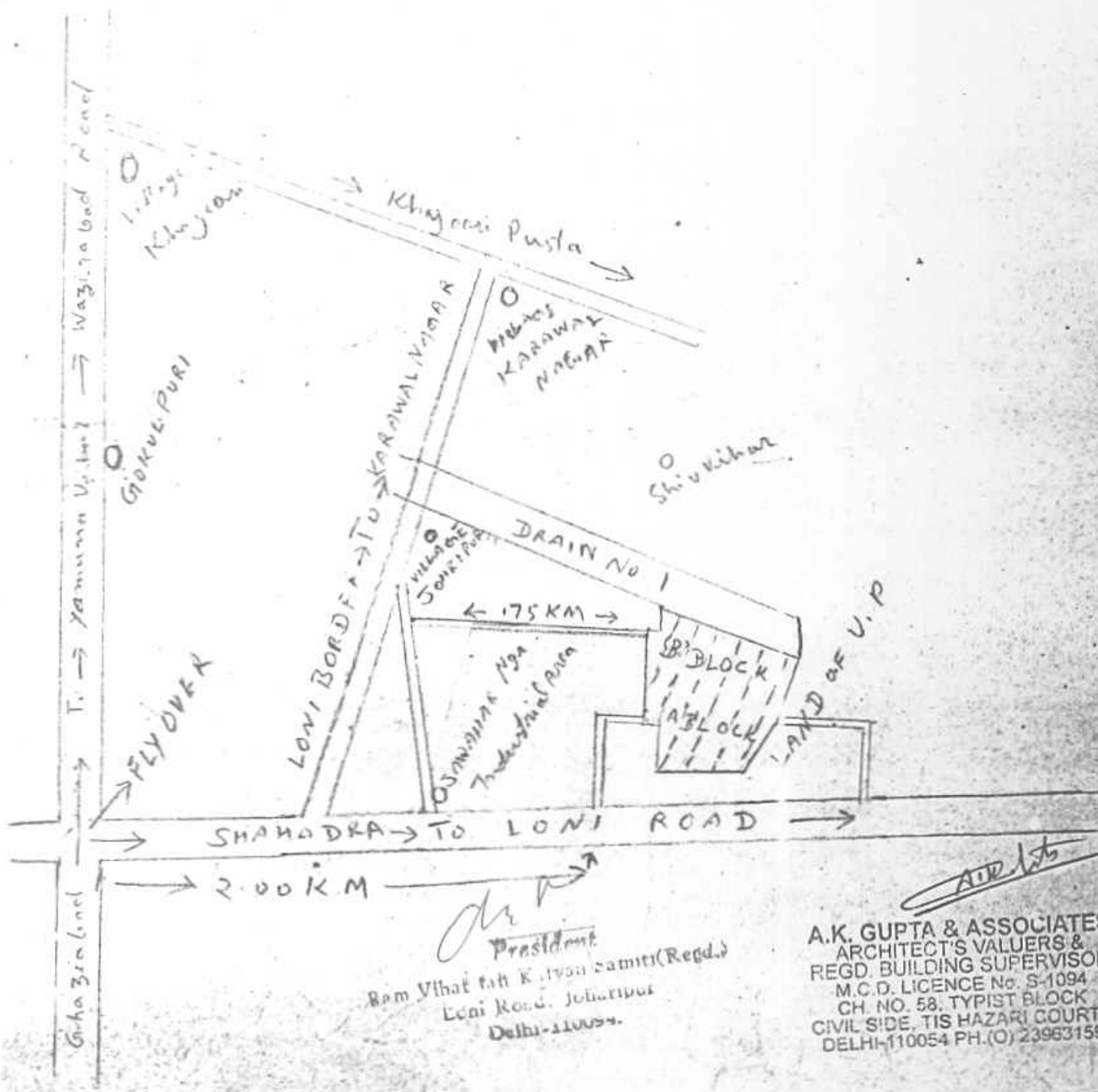

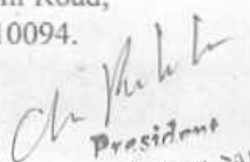

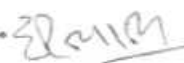
