Reference letter dtd. 18th November, 2005 addressed to Shri Sajjan Kumar, Member of Parliament by the Lt. Governor, Delhi, with a copy endorsed to Chairman, DSIDC regarding alleged acquisition of built up area in Anandpur Dham Colony at Karala.

In this behalf, it is stated that we had earlier received a letter from the Area MLA through the office of Chief Minister, Delhi, in January-2005. The matter was processed & referred to the Minister of Industries for a decision. The Hon'ble Minister decided as under:-

"The existing policy of not acquiring built up area has to be adhered to but since the details and boundaries of the area of the colonies to be regularized is not yet available, it will not be prudent to exclude the area from Notification for acquisition. At this stage we may go for the Notification of entire area proposed for acquisition. The built up area of the colonies under consideration for regularization may be excluded from declaration under Section-6 of the Land Acquisition Act if the colonies are regularized."

And accordingly Land & Building Department has gone ahead with the Notification under Section-4. Since there is a colony it is now open for the Land Acquisition Collector to exclude the same while conducting his hearing under Section-5 A of the said act and exclude the same under Section-6. The same also meets with the decision of the Minister of Industries in the concluding part of his decision.

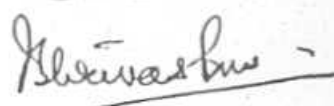
A final view in the matter is to be taken by the Land & Building Department only.

Lands at village Kanjhawala, Karala and Sultanpur Dabas were notified under Section-4 & 6 for relocation of industries. There were certain unauthorized colonies existing on this land at the time of notification. A decision was taken by Hon'ble Minister of Industries not to exclude the colonies from notification under section-4 for acquisition but the built up areas could be excluded under declaration of section-6 of the LAC Act. This decision was communicated to L&B Department and the OSD to LG vide U.O.note dtd.12.12.05. The process of land acquisition, however, continued and the Land Acquisition Collector has since announced the awards and while taking over possession some 100 acres of land has been left out. In support of this the LAC has made available a copy of letter dtd.11.9.07 issued by Addl.Secy.(L&B) conveying the decision of Hon'ble L.G. not to take over lands where unauthorized colonies are being regularized.

In view of this you are requested to kindly look into the matter and in case this land is not to be taken-over then alternative land may be identified. The manner in which the vacant land is to be dealt with within the left out areas, be also decided and conveyed to us at the earliest.

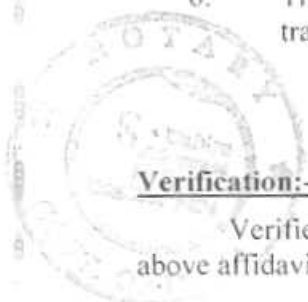

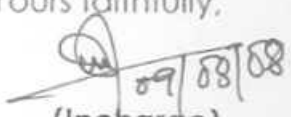

1. Name of the Society:

The name of the Society shall be:

2. Membership:

The Executive Committee shall decide the annual subscription and entrance fee for membership from time to time. All annual subscriptions are payable in advance within two months of the commencements of the calendar year, except in the case of new members who will send their subscriptions together with the enrollment form for membership.

5. Cessation of Membership:

Any member shall cease to be a member on his/ her resignation from membership by letter addressed to the President of the Society. Any member shall cease to be member of the Society if he/ she fails to pay all the arrears due to the Society within sixty days of the receipt of 'Payment Notice' from the President of the Society. Such person whose membership has been terminated, may be reinstated after the payment of the arrears due to the Society with the approval of the executive Committee. - d). To accept from the Government, Organizations, Institutions and Individuals gifts, grants donations, bequests, endowments, special fees and subscription of cash and securities for the furtherance of the objects of the Society.
- e). To deposit any money or Securities in the name of the Society, with any bank and withdraw the same and invest money and belongings to the Society in securities in accordance with law.
- f). To approve the funds of the Society for meeting its aims and objects.
- g). To do or get done all such other lawful acts and things connected with the aims and objectives of the Society.
- h). To retain, promote, appoint or dismiss any employee or personnel functioning under the Society.

contd...

- i) To maintain the discipline and dignity in the Society.
- j) To make, observe, amend, execute rules and regulations and by-laws for the conduct, control and regulation of the activities of the Society on the recommendations of the Executive Committee or otherwise.

Notice of Meetings and Periodically of the Meetings:

The annual general meeting of the General Body shall be held at least once every year and not more than sixteen months shall elapse at least between two successive annual general meetings. At least 14 days notice specifying the time, place and date shall be given to every member for convening the annual or extraordinary general meeting.

9. Executive Committee:

The Executive Committee shall be the elected body of the office bearers who shall act and behave on behalf of the Society to meet out and achieve the aims and objects of the Society.

a) Minimum and Maximum Strength including the office bearers:

The minimum strength of the office bearers of the Society shall be 5 and maximum limit shall be 25.

b) Composition:

The executive/ The Managing Committee may have the maximum following Office bearers:

President	:	1
Vice President	:	Minimum 1 & maximum 4
Secretary	:	1
Cashier	:	1
Member	:	minimum 1 maximum 18

c) Election and its mode:

Office bearers of the Executive Committee shall be elected in the Annual General Meeting for years by the secret ballot or by raising hands or simple majority. The Election Officer will conduct election.

d) Terms of the office of the Executive Committee:-

Normally the term of the Executive Committee shall be for two years. However, it can be extended for another one year, in case of abnormal circumstances.

e). Powers and Duties of the Office bearers:

- i. To conduct or look after the activities of the Society.
- ii. To appoint, recommend, suspend or terminate the members of the society, as per rules and regulations of the Society.
- iii. To accept the income expenditure account, as per rules and regulations of the Society.
- iv. To accept the donations, grant etc. for the objects of the Society, as per rules and regulations of the Society.

President:

President shall preside all meetings of the Society. He shall keep the Executive Committee and members informed about the activities and financial affairs of the Society. She will supervise the work of the Society in general. She shall an ex-official member of all the Committees constituted by the Executive Committee. The Committees so constituted shall be answerable/responsible to the President and the President may take the report

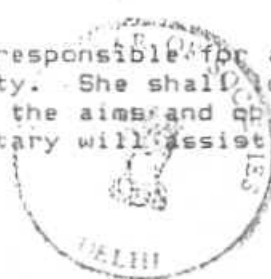
before the executive Committee. President on its own motion or consultation with the Executive Committee may organize/ appoint Committee/ Sub-Committee/Cell/ Board organize in small groups and name them as committee/ cell/ department in furtherance of the Society's aims and objectives and the same may be dissolved/terminated/ suspended by the President. Even a non-member having faith and belief in the aims and objects of the society may also be appointed by the President, for the any part of the said Committee/Cell/department.

Vice-President:

Vice-President shall assist the President in carrying out his responsibilities. in the absence of the president, the Vice- President shall perform all duties of the President.

Secretary:

She shall be responsible for arranging the meetings of the Society. She shall look after the working and promote the aims and objects of the Society. Joint Secretary will assist the secretary in her job.



Treasurer/ Cashier:

The Treasurer shall advise the president and Secretary on financial matters. She shall manage/ help in managing financial matters so as to run the Society. Assistant cashier will assist the Cashier/ Treasurer in her job.

f). Quorum and Notice of the meeting:

The quorum for the meeting of the Executive Committee shall be one-third. The Executive Committee shall meet to transact Business at least once in three months. Generally, a notice of 14 days shall be required for holding the meeting but emergency meetings can also be called on short notices.

g). Filling of the casual vacancies:

If any vacancy occur in the office of any office bearer of the Executive Committee, during the interval between two annual general meetings or if during the election, any post of the office Bearer does not fill the vacancy may be filled by the nominating the remaining members of the Executive Committee.

h). Sub-Committee, if any:

Sub-Committees shall/ may be established or Incorporated with this Society, as per rules and regulations of the Society.

10. Sources of income and utilization of funds:

i. The funds of the society shall be applied for carrying out the aims and objects of the Society, which is charitable in nature without distinction of caste, color, or creed.

ii. The Society is not organised for the profit and all incomes and properties whenever, derived shall be applied solely towards the furtherance of the objects of the Society.

iii. The sources of income of the Society are fee, grant, aids and other sources, which is purely non-profit making.

11. Audit of Accounts:

The accounts of the society shall be examined and correctness of the Income and Expenditure Account and Balance sheet shall be ascertained by an Auditor every year. The General Body in meeting shall decide the appointment of the Auditor every year.

12. Operation of Bank Accounts:

The Bank Account of the Society is to be opened in any Nationalised Bank, scheduled Bank or Co-Operative Bank. The bank account can be operated with the signatures of Secretary/President and Treasurer in the cheque and other etc. Further the President may delegate the power to sign on the cheque to any member of the Executive Committee on his behalf.

13. Financial Year:

Financial year for maintenance of the account and other matters shall commence from 1st day of April and end on 31st of March, every year.

14. Annual list of Executive Committee Governing Body (Sec. 4 of the Act):

Once in a year a list of the office bearers and members of the Governing Body of the Society shall be filed with the Registrar of Societies, Delhi as required under Section 4 of the Society Registration Act, 1860.

15. Legal proceedings

The Society may sue or be sued in the name of the President/ Secretary as per provisions laid down under sec. 6 of the Society Registration Act, 1860 as applicable to the Union Territory of Delhi.

16. Amendment in the Memorandum of Association:

An amendment in the Memorandum of Association or rules shall be carried out in accordance with the procedure laid down under Sec. 12 and 12-A of the Society Registration Act, 1860.

17. Dissolution and Adjustment of Affairs:
