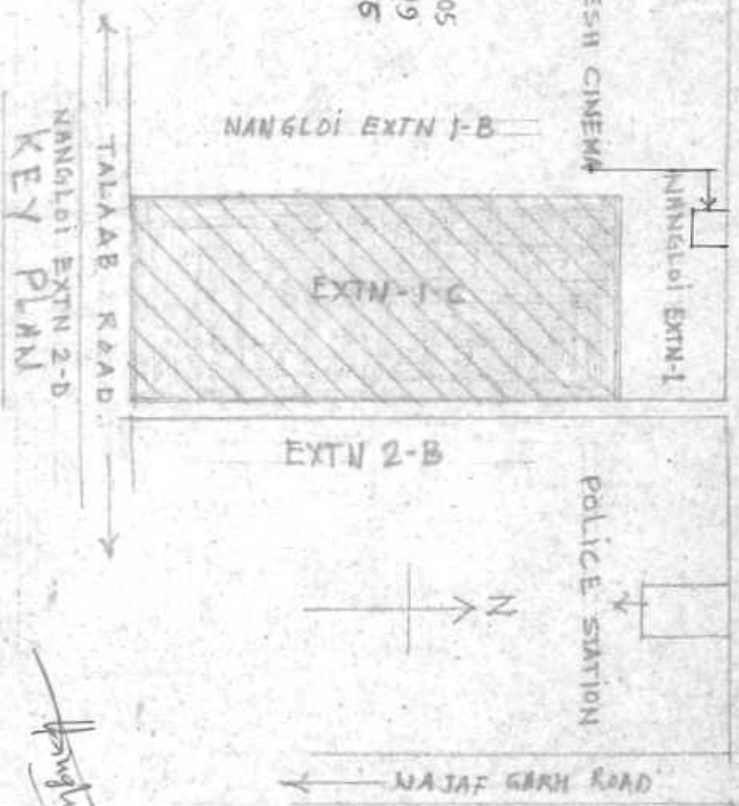
KEY PLAN OF NANGLOI EXTN 1-C NANGLOI 14C NEW DELHI - 110041

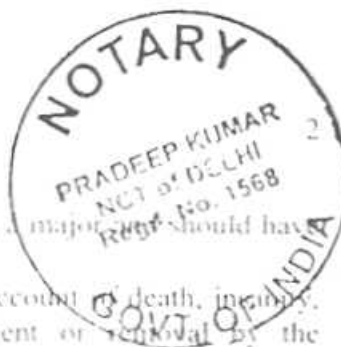

In these Rules, unless the context otherwise requires.

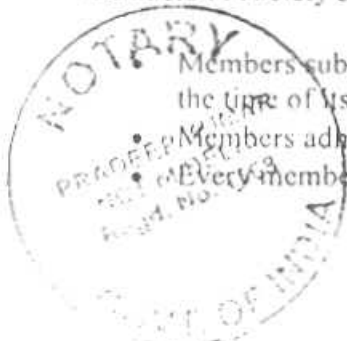
- Managing Committee shall mean the Managing Committee constituted under these Rules & Regulations.
