Every expenditure shall require the sanction of the General Secretary. He will represent or authorise the any other member to represent on behalf of the society for dealing with other persons, Govt/semi-Govt bodies etc. General Secretary shall represent the society and shall sign all the papers/documents on behalf of the society.


