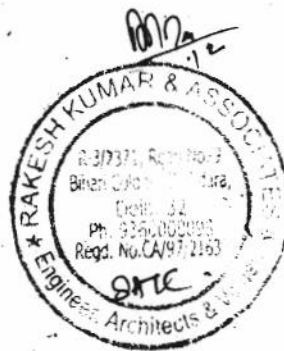

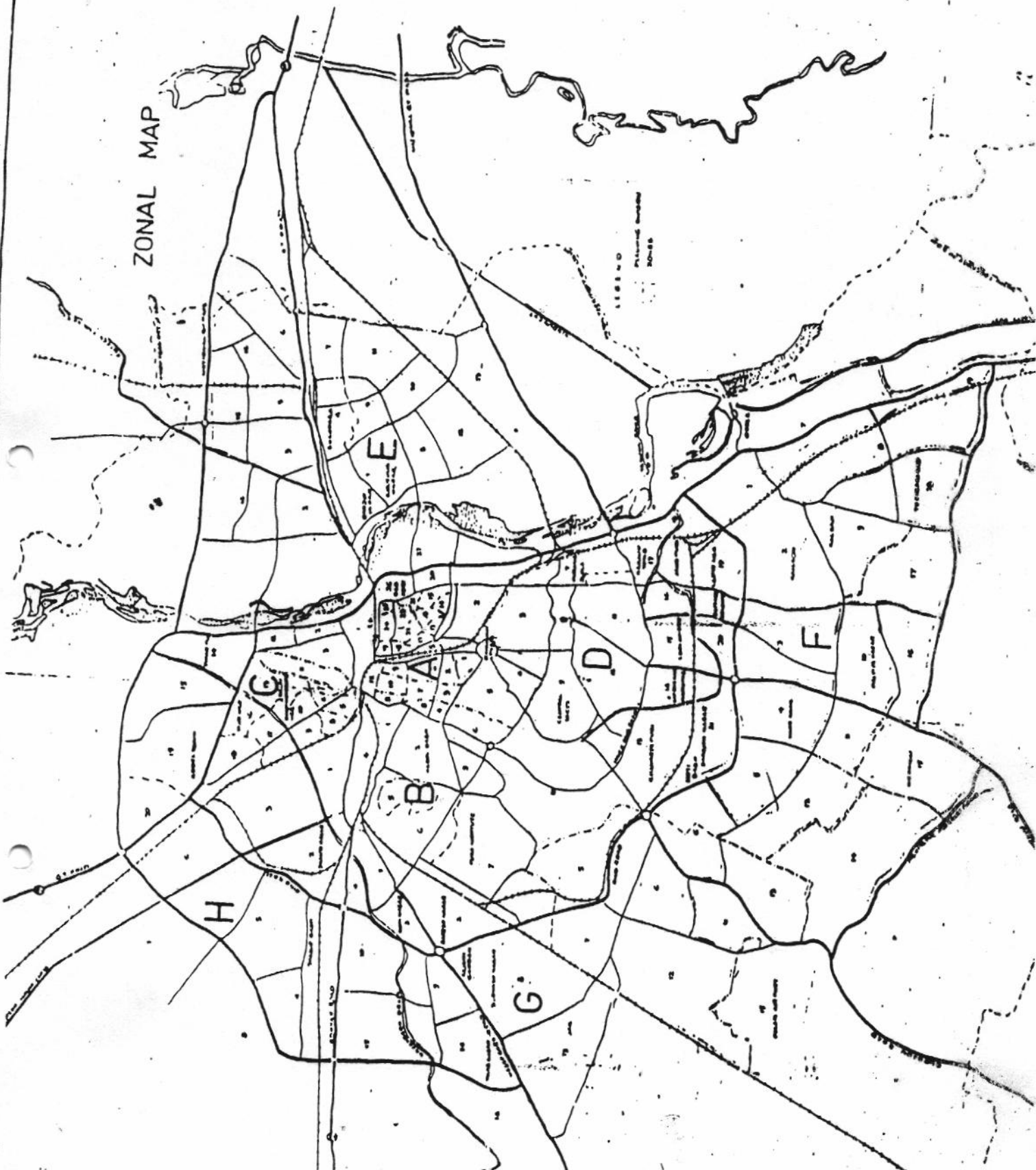

I am directed to refer to your representation dated NIL on the above cited subject and to inform that the matter was examined in this Directorate in view of the points mentioned in the representation and found that most of the points of the representation pertain to the office of Dy. Commissioner, Delhi, & Development Commissioner, GNCT of Delhi.

The Development Commissioner, GNCT of Delhi, & Dy. Commissioner (South), Delhi, have already been requested by this Directorate separately vide letters dated 14.1.97 & 15.1.97 respectively to look into the matter pertaining to their Departments for appropriate action. The above authorities have also been requested not to disturb the peaceful living of the residents of the Harijan Basti, Neb Sarai, New Delhi, as the above SC Basti was settled under 20-point programme by the govt agencies in the past and such cases may be exempted from demolition for the purpose of creation of Reserved Forests in 'Ridge Area'.

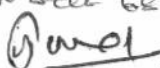

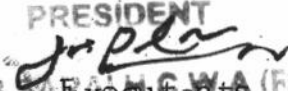

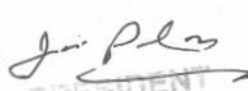
