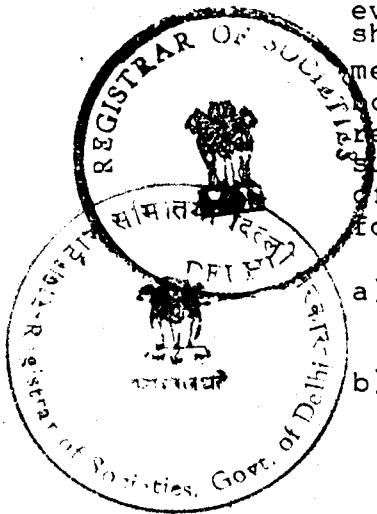
8. RIGHTS AND PRIVILEGES OF THE MEMBER:
