22. **DISSOLUTION:** If the society needs to be dissolved, it shall be dissolved as per provisions laid down under the sec. 13 & 14 "SOCIETIES REGISTRATION ACT, OF 1860" as applicable National Capital Territory of Delhi.

23. **LEGAL PROCEEDING:** Society may sue and /or be sued in the name of President as per provision laid down under sec. 6 The "SOCIETIES REGISTRATION ACT, OF 1860", as applicable to National Capital Territory of Delhi.

24. **AMENDMENT:** Any amendment in Memorandum, Rules and Regulations will be carried out in accordance with section 12 & 12A of the "SOCIETIES REGISTRATION ACT, OF 1860", as applicable to National Capital Territory of Delhi.

25. **APPLICATION OF THE ACT:** All the provisions under all the section of the "SOCIETIES REGISTRATION ACT, OF 1860", as applicable to National Capital Territory of Delhi shall be applicable to this society.

18. **FINANCIAL YEAR:** Financial year of society shall start from 1st, April to 31st March every year.

19. **AUDIT:** The accounts of society shall be audited by the qualified auditor (Chartered Accountant) every year.

20. **MANAGEMENT OF FUNDS & ACCOUNTS**

A. Bank Accounts shall be operated by joint signatures of Treasurer and any one out of President and General Secretary.

B. The funds of the society shall be invested and kept invested only in such properties securities and or investment which are permissible under section 11(5)

12. POWERS AND DUTIES OF OFFICER BEARERS:

PRESIDENT

- a) President shall preside over all the meetings of the society.
- b) At the time of voting on any matter/ subject (except election), if the total votes of the groups of members happen to equal in number, the President has the power to cast an extra vote to decide the matter/ subject.
- c) President shall have the power to allow inclusion of any subject/ matter in the agenda for the discussion in the course of proceedings/ meetings.

JT. SECRETARY : The Jt. Secretary shall enjoy all the powers of Secretary in his/her absence.

TREASURER

- a) All funds of society shall remain the care and management of Treasurer.
- b) Treasurer shall maintain the accounts of all money, which is received and/or paid by him/her on behalf of the society.
- c) Treasurer shall make disbursement in accordance with the direction of Governing Body.



- b) TERMS: Terms of every Governing Body shall be FL YEARS. The present governing body shall be taking care of the society the new election takes place.
- c) NOTICE: Minimum 7 days notice shall be required for every Governing Body meeting of the society but urgent Governing Body meetings can be called by 4 hours notice.
- d) QUORUM: Quorum of every Governing Body meeting shall be  $\frac{2}{3}$ rd of the total strength of the Governing body (including office bearers and executive members)
- e) MEETING: Governing body meeting shall be held once in three months regularly (or as and when the Governing Body of the society may decided from time to time).
- f) URGENT MEETING: The urgent Governing Body may be called by the 24 hour notice.

#### 10. FUNCTIONS & POWERS OF GOVERNING BODY:

- b) Have right to collect the Identity card of the society by depositing the required/ prescribed (fixed by the Governing Body of the Society from time to time).

- b) Attend the General Body meetings regularly.
- c) Give the necessary information to the society pertaining to any matter, which is necessary to the society.
- d) Not indulge in activities, which are prejudicial to the aims and objects and/ or the Rules & Regulations of the society.

3. WORKING AREA : Delhi

4. AIMS AND OBJECTS : The Aims and Objects for which the society established are as under:-


