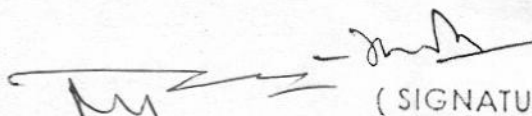

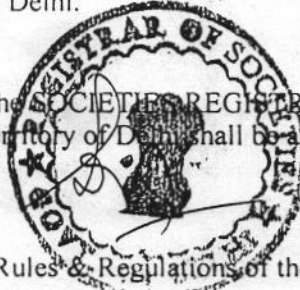

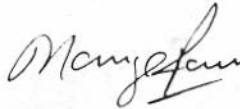

17. BRANCHES OR THE SUB COMMITTEES.

The Governing body, in its meeting shall form the branches and/or the sub committee all over India and abroad to attain the Aims and object of the society.

18. ADVISORY BOARD:

The Governing body is authorized appoint/nominate, any time, the advisory board to solve any matter/issue. The Governing body of the society can nominate any office bearer/executive member as the chairman of this kind of advisory board.

19. SOURCE OF INCOME:

All the income of the society received from all sources shall utilized only for the promotion and upliftment of the aims and object of the society. The sources of income of the society are under:-

- Admission fee and subscription from the members of the society.
- Donation and special contribution.
- Fund generated by Exhibitions, Functions, seminars and other cultural programmes arranged by the society.

20. FINANCIAL YEAR:-

The financial year of the society shall start from 1st day of April to 31st day of March every year.

21. MANAGEMENT FUNDS AND ACCOUNT OPERATION:-

All the amount shall be kept in any Nationalized bank(s) and the Bank accounts shall be operated by the Joint Signatures of Treasurer and any one out of President and General secretary.

22. AUDIT:

The accounts of the society shall be audited by the qualified auditor (C.A.) every year.

29. ANNUAL LIST OF GOVERNING BODY:

Once in every year a list of the office bearer and the executive members (of the Governing Body) shall be titled in the office of the Registrar of Societies.

30. DISSOLUTION:-

If the society needs to be dissolved it shall be dissolved as per provisions laid down under the Sec. 13 & 14 of SOCIETIES REGISTRATION ACT 1860 as applicable to National Capital Territory of Delhi.

31. LEGAL PROCEEDING:-

Society may sue and/ or be sued in the name of President as per provisions laid down under Sec. 6 of the SOCIETIES REGISTRATION ACT 1860 as applicable to National Capital Territory of Delhi.

- t) General secretary will get the accounts of the society audited by the qualified auditor, appointed by the Governing Body of the society.

D) SECRETARY:

- c) All the funds of society shall remain under the care and management of Treasurer of the society.
- d) The Secretary shall enjoy all the powers of General Secretary in his/her absence.

E) TREASURER:

- g) All the funds of society shall remain under the care and management of treasurer of the society.
- h) Treasurer shall maintain the accounts of all money which is received and/or paid by him/her on behalf of the society.
- i) Treasurer shall make disbursement in accordance with the direction of Governing Body.
- j) The Treasurer will ordinarily hold a cash balance not exceeding Rs. 1000/- or the amount which may be fixed by the Governing body of the society from time to time) to meet the emergent needs relating to the society.
- k) All the cash excess of the above amount (or the amount fixed by the Governing Body) shall be deposited in any Nationalized Bank/Banks, selected by the Governing body of the society.
- l) EXECUTIVE MEMBER:

- a) The Executive member is bound to inform the society in writing if he/she is not able to attend any particular meeting of the Governing body and/or General body.
- b) Executive member will be terminated, if he/she not attends the consecutive meeting of the Governing body.

b. RE-ADMISSION:

In case, any member of the society is expelled by the Governing body on the ground of Non-payment of the subscription, he can be re-admitted, provided the member concerned pays and up to date dues with the permission of the Governing body.

14. APPEALS:

All the appeals shall be referred to the General body of the society. The decision of the General body shall be final.

15. FILLING UP CAUSAL VACANCIES:

Any causal vacancy amongst the office bearers and executive members of the Governing body, shall be filled by the resolution passed by the Governing body, such appointment(s) shall be confirmed by the Governing body in this coming General body meeting.

16. ELECTION:

The General body in its annual meeting will elect its President and all the office bearers and also the Executive members of the Governing body. After every five years by secret ballot papers or by show of hands as the election officer may decide. The election officer will be appointed by the Governing body. The powers of election officer shall also be framed by the Governing body of the society.

12. POWERS AND DUTIES OF OFFICE BEARS:

a) PRESIDENT:

- d) At the time of voting on any matter/subject (except election), if the total votes of the groups of members happen to be equal in numbers, the president has the power to cast an extra vote to decide the matter/subject.

B) VICE PRESIDENT:-

- i. there shall be one vice-president of the society to assist the president in his/her work.
- ii. The Vice President shall enjoy all the powers of the president in his/her absence.

C) GENERAL SECRETARY:-

General secretary shall be the subject to control and supervision Governing body; have the power to make general directions and management of the affairs relating to the society.

General Secretary of the society shall also enjoy the following powers and duties:-

- f) General secretary will summons and attend the meeting of Governing Body and the General Body
- g) General Secretary will prepare the membership register as well as the proceeding Register to record the minutes of the proceeding of the Governing body meetings and the General Body Meetings and have them duly signed by the members who attend the meetings.
- h) In the course of any proceedings or meeting of the governing body or the General Body, the decision of the General secretary shall be considered as final (in case of dispute as to the meaning or interpretation or any rule.)
- i) General Secretary shall have the power to allow inclusion of any subject matter in the agenda for the discussion in the course of proceedings meeting.
- j) In case it is necessary to decide any point/matter issue urgently and there is no time to call the Governing body meeting, the General secretary have the powers to decide the point/issue/matter but he/she shall bring the matter to the notice of the governing body as early as possible.
- k) General Secretary will sign all the papers/letters, on behalf of the society to conduct its correspondence.
- l) General Secretary will also authorized to appoint/terminate such staff as may be required for effective and efficient management of the affairs of the society.
- m) In case event of any office bearer(s) seat falling vacant, the powers and functions of that office bearer/executive member would vest in the General Secretary of the society.

8. DUTIES OF THE MEMBERS:

- d) **QUORUM:** Quorum of every Governing Body Meeting shall be 2/3 rd of total strength of the Governing Body(including office bearers and executive members).
- e) **MEETING:** Governing Body meeting shall be held once in Three Months (or as and when the Governing Body of the society may decided from time to time).
- f) **URGENT MEETING:** The Urgent Governing Body may be called by the 24 hours notice but the quorum for the same urgent Governing body meeting shall be 2/3 rd the total strength of the Governing body of the society.

10. FUNCTIONS & POWERS OF GOVERNING BODY:

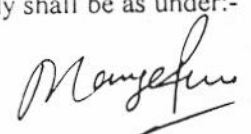
- k) Governing Body shall be responsible for the management and administrative of all affairs of the society, and is also authorized to appoint any office bearers/executive member to look after any particular activity.

 - s) To make any rule for social welfare and welfare of the society of the society

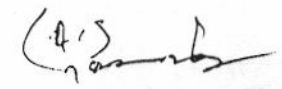

1. NAME OF THE SOCIETY:

a. Admission Fee Rs. 100/- at the time of admission

b. Subscription Rs. 25/- per month

4. TERMINATION FOR CESSATION MEMBERSHIP:

The Governing Body of the Society shall have the powers to expel/terminate a member or/and members, from the membership of the above society, on the following grounds:

a. on death

b. on written resignation;

c. if found to be involved in any anti social activities.

d. If adjudged by any court of law to be a criminal offender or unsound mind;

e. If found guilty by means of anti propaganda of the aims and objects of the society;

f. If fails to pay the subscription of contribution for three months from due date;

g. If has not attend three consecutive meetings without proper intimation;

h. If disregards Rule & regulations or disobey the decisions of the Governing body;

NOTE: The decision of the Governing Body regarding the termination from the membership of the society;

6. GENERAL BODY:

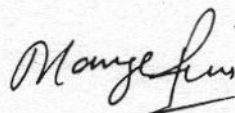
