MINUTES OF THE MEETING HELD UNDER THE CHAIRMANSHIP OF  
HON'BLE CHIEF MINISTER ON 17th OCTOBER, 1997 REGARDING  
ACQUISITION OF LAND AT ANAND PARBAT (SIDHORA KHURD)

2. It was informed that in the year 1959 process for acquisition of Ramjas Foundation's Land measuring about 1500 bighas at Sidhora Khurd popularly known as Anand Parvat was initiated. In all five Notifications were issued in this case during 1968-69. Possession of 87 Bighas and 13 Biswas was taken over and handed over to DDA in 1995. The present issue pertains to acquiring of 78 Bighas and 14 Biswas. The acquisition proceedings in this case have been upheld by the Hon'ble Supreme Court of India in SLP No.2213 of 1978 and award(s) issued in 1994.

3. It was informed that under the Master Plan, this area falls under industrial zone. Hon'ble C.M. mentioned that even if planned development of this area is to be done, it should be done by relocating the existing industries in phased and planned manner.

4. It was also informed that as on date no scheme/plan for this area has been made by DDA.

5. Keeping in view the prevailing facts and circumstances, it was decided that:-

(i) This issue will be dealt by North District under whom this area falls.

(ii) Detailed survey of the area be completed by 30th December, 1997. Residents Association assured all cooperation in this regard.

(iii) A detailed Scheme/Plan for development of this area be prepared by 28th February, 1998.

(iv) No demolition action be taken till further orders from competent authority.

(v) MCD may renew adhoc licences of this area.

6. Meeting ended with a vote of thanks to the Chair.

Respected Sir,

Anand Parbat Residents Association, a representative body of the residents of Ramjas Nagar, Anand Parbat most respectfully submit as under :-

- (a) The Anand Parbat area, formerly property of Ramjas Foundation has been a confirmed educational and residential area since 1920. The residents are living for the last 40 or 50 years.
- (b) Now DDA has taken over the possession of this area on 'as is where is' basis and submitted an affidavit in the Delhi High Court to re-develop the area as per Master Plan 2001.
- (c) In 1956/57 the area was declared as Notified Slum area under Section 3 of the Slum Act 1956.
- (d) We the residents of the area request your honour to issue necessary orders for re-development and levy Development-Charges from the residents.
- (e) As per rule MCD is responsible for development of Slum, so kindly hand over the area to Municipal Corporation for development.
- (f) Previously The Ramjas Foundation was supplying water, but now the possession of the land is with DDA. No Govt agency has taken over the responsibility for supply of water in this area. So the supply of water may kindly be taken over by Jal Board or Corporation immediately. The residents are facing a great difficulty for drinking water.
- (g) The area is a semi-hilly and it has been requested so we request to develop the area as Rock-Garden.
- (h) In the previous meeting with the then M. Shabir Singh, it was settled that the area would be developed by MCD but no action has been taken in this regard.

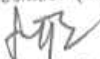

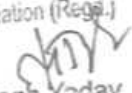

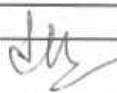

- (c) To help people in distress during natural calamities such as fire, flood, earthquake and other distresses.
- (d) To establish charitable dispensaries.
- (e) To establish, start, run, take over, manage and maintain schools, reading rooms and library to provide education.
- (f) To organize festivals, satsangs and other religious functions from time to time depends on the decision of the Executive Committee.
- (g) To maintain Barat Ghar, Community Hall for the benefit of public/residents.
- (h) To approach concerned authorities for solution of problems of the members/residents of the colony.
- (i) To keep a watch on safai karamcharies deputed in the area to ensure their proper work.
- (j) To manage civic amenities and public facilities with the help of concerned Govt departments.

The list of the participants is enclosed at Annexure-I.

2. It was informed that in the year 1959 process for acquisition of Ramjas Foundation's Land measuring about 1500 bighas at Sidhori Khurd popularly known as Anand Parvat was initiated. In all five Notifications were issued in this case during 1968-69. Possession of 87 Bighas and 13 Biswas was taken over and handed over to DDA in 1995. The present issue pertains to acquiring of 78 Bighas and 14 Biswas. The acquisition proceedings in this case have been upheld by the Hon'ble Supreme Court of India in SLP No. 2213 of 1978 and award(s) issued in 1994.

3. It was informed that under the Master Plan, this area falls under industrial zone. Hon'ble C.M. mentioned that even if planned development of this area is to be done, it should be done by relocating the existing industries in phased, and planned manner.

4. It was also informed that as on date no scheme/plan for this area has been made by DDA.

5. Keeping in view the prevailing facts and circumstances, it was decided that:-

- (i) This issue will be dealt by North District under whom this area falls.
- (ii) Detailed survey of the area be completed by 30th December, 1997. Residents Association assured all cooperation in this regard.
- (iii) A detailed Scheme/Plan for development of this area be prepared by 28th February, 1998.
- (iv) No demolition action be taken till further orders from competent authority.
- (v) MCD may renew adhoc licences of this area.

6. Meeting ended with a vote of thanks to the Chair.

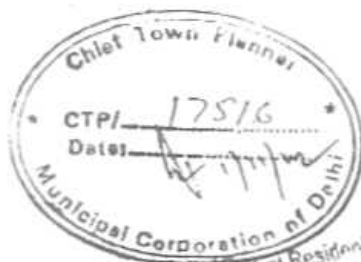
1. Ref our representation dated 23<sup>rd</sup> Nov 1999 to Principal Secretary, UD and his letter No.58/Public UC/99/665 dated 31-12-99 and No.752 dt 28 Jan 2001 to the Town Planner to enquire the factual position of the said colony (photo copies of these letters are attached).

2. As you know that this area was a private property of Ramjas Foundation known as "Ramjas Estate", so it was not reflected in the map of the Town Planner. The area was under acquisition since 13<sup>th</sup> Nov 1959 and remained embroiled in litigation. Therefore, it was not shown in the map of the Town Planner, MCD.

3. Now the land has been taken over by the Govt. The land use in Master Plan 2001 is public and semi Public facilities, District Park, residential, light service Industries and Govt land.

4. In fact, this colony was established in 1918 and partly in 1943 i.e. pre-independence. All basic civic amenities/facilities are there and it has been a confirmed residential area since then. It fulfils all the requirements essential for a regularised colony. Details of the same are given below :-

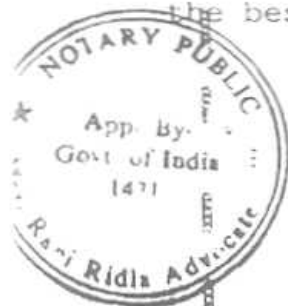

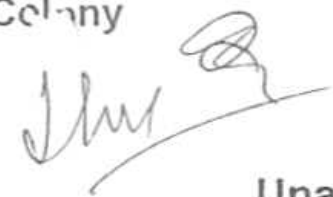
