An early consideration of the issue shall be in the interest of the work and the department.

Court as per the latest information given by the office of Dy. Director (NL). The peripheral S.W. Drain of Sector 28 has already been constructed, the discharge of which is to go through this proposed outfall drain for which the land could not be made available so far. As a result this area is completely water logged during the rainy season and the peripheral and internal roads constructed are damaged frequently due to water logging. Recently this office has received a proposal from Residents' Welfare Association, Prahlad Vihar that they are willing to give an undertaking/affidavit for surrendering the area required for the passage of the required services through a particular route suggested by them, the copy of the letter duly signed by President & Secretary Residents' Welfare Association, Prahlad Vihar alongwith the layout plan showing the piposed route is enclosed herewith for ready reference. This proposal of the Residents' Welfare Association needs to be examined by your branch in view of the pending court case before the Hon'ble Supreme Court. If required, the opinion of the Legal Cell may also be taken on the subject. With reference to above it is brought to your notice that DDA is developing Phase-IV & V comprising of Sector 26 to Sector 42. Out of this Sector 26 to 33 falls under Phase-IV & Sector 34 to 42 falls under Phase-V. As per planning the storm water of this area is to be disposed of through the existing supplementary drain near Rithala. There is a proposal for construction of outfall drain from Village Pooth Khurd upto supplementary drain near Rithala. This drain has been designed for a flow of 2100 cusec and shall cater for an area of 1700 hectares. The additional flow of 55 cusec from the village area has also been considered into it. The total length of this drain is 7000M. The portion of this drain having discharge more than 1000 cusec is to be constructed and maintained by the Flood & Irrigation Department for which land was to be provided to them by DDA. The area coming under the catchment of this drain has either been developed and allotted or is under development. The land through which this drain is passing through Sector 26 is under stay in a Suit filed by Residents' Welfare Association, Prahlad Vihar and the matter is pending before the Hon'ble Supreme



#### Report of the Joint Survey Team on

#### Prehlad Vihar (Prehlad Vihar Residents' Welfare Association)

Secretary (UAE) vide letter no. SECY/UAE/PV/D/99 dated 15th February, 1999 constituted a Joint Survey Team comprising of Shri D.S. Meshram, Chief Planner, TCPO and Shri Shamim Ahmed, Director (LM), Hq. DDA for conducting survey to ascertain the details of the site which is in the possession of Prehlad Vihar Residents' Welfare Association and the structures which are inhabited / not-habited and other relevant information. The responsibility of co-ordination of the Survey Team was assigned to Shri A. Ramaswamy, Principal Commissioner, DDA.

During the preliminary discussions held on 18-02-99 in the chamber of Shri Ramaswamy, Principal Commissioner, DDA, it was observed that detailed plan of the area showing roads / plot boundaries / existing structures, etc., is not available with DDA. Therefore, basework was done on the map received from the Prehlad Vihar Residents Welfare Association.

The members of the Joint Survey Team alongwith surveyors / revenue staff / officers and staff of the DDA and TCPO surveyed the area on 19th (Saturday) and 20th (Sunday) February 1999. After the survey, information collected was incorporated on the map and the team visited the site again on 24-02-95 to ascertain actual position on the ground. The existing information / details were reconciled and incorporated on the map. On the basis of the khasra boundaries made available by Shri Shamim Ahmed, Director (LM), Hq. DDA, the boundary of the area was also marked on the map and accordingly the area works out to 113.27 acres (refer map).

With reference to the plot boundaries shown on the map by the Association, it was observed that in some plots only boundary makes 1st, while in some of the plots one ream structure exists (with roof or without roof). The boundary walls existing on the site are not only for single plot but also cover group of plots in some cases. Most of the plots inhabited are small sized. There are also some large sized inhabited plots but they are scattered and located sparsely (refer map). Thickly inhabited contiguous pocket is shown on the map in orange colour which indicates that major development has taken place in the north-eastern and central part of the colony.



#### Report of the Joint Survey Team on

Probled Viliar (Probled Viliar Residents' Welfare Association)

Secretary (UAE) vide letter no. SECY/UAE/PV/D/99 dated 15th February, 1999 constituted a Joint Survey Team comprising of Shri D.S. Meshram, Chief Planner, TCPO and Shri Shamim Ahmed, Director (LM), Hq. DDA for conducting survey to ascertain the details of the site which is in the possession of Prehlad Vihar Residents' Welfare Association and the structures which are inhabited / not-habited and other relevant information. The responsibility of co-ordination of the Survey Team was assigned to Shri A, Ramaswamy, Principal Commissioner, DDA.

During the preliminary discussions held on 18-02-99 in the chamber of Shri Ramaswamy, Principal Commissioner, DDA, it was observed that detailed plan of the area showing roads / plot boundaries / entiting structures, etc., is not available with DDA. Therefore, basework was done on the non-received from the Prehlad Vihar Residents Welfare Association.

The members of the Joint Survey Team alongwith surveyors / revenue staff / officers and staff of the DDA and TCPO surveyed the area on 19<sup>th</sup> (Salurday) and 20<sup>th</sup> (Sunday) February 1999. After the survey, information collected was incorporated on the map and the team visited the site again on 24-02-99 to ascertain actual position on the ground. The existing information / details were reconciled and incorporated on the map. On the basis of the khasra boundaries made available by Shri Shamim Ahmed, Director (EM), Hq. DDA, the boundary of the area was also marked on the map and accordingly the area works out to 113.27 acres (refer map).

With reference to the plot boundaries shown on the map by the Association, it was observed that in some piots only boundary walls of at, while in some of the plots one room structure exists (with roof or without roof). The boundary walls existing on the site are not only for single plot but also cover group of plots in some cases. Most of the plots inhabited are small sized. There are also some large sized inhabited plots but they are scattered and located sparsely (refer map). Thickly inhabited contiguous pocket is shown on the map in orange colour which indicates that major development has taken place in the north-eastern and central part of the colony.
