



May please find enclosed a duly verified set of report about site verification and built up percentage of plots in the 1639 unauthorised colonies enlisted by the U.D. Department, GNCTD.

In the past also, this office had provided the report of built up percentage pertaining to 1432 list (District-wise) and only about 150 colonies report could not be provided, since some of the colonies could not be located on the aerial photographs. This was because the RWAs had not provided proper key plan with sufficient surroundings/landmarks to locate the colony.

It is to state that this Department has regularly been conveying during the meetings with the Hon'ble Minister that some of the files have been observed to be misplaced, out of MCD/DDA colonies and the report could, therefore, not be provided. Such colonies have been indicated in the list under "Remarks". A few other observations in the remarks may also please be seen in respect of the colonies being primarily commercial or Industrial, or else consisting of only a single plot or almost all the plots being consisting of farmhouses.

Earlier vide letter dt.17-7-2009, this office had provided the report of built up percentage pertaining to the year 2002 and also 2008-09. 



examining the question of regularization arising from such applications filed. The application in respect of Samalkha Extension, Block A & B, was yet to be examined. Protection was granted against taking over possession of the land till such time as the question of regularization was decided.

The applicants before us today plead that monies were taken from them in early 1970s for allotting plots in a Transport Complex which had to be set up on the land in question. The effect of not taking over possession from the petitioners is that the applicants are not getting their plots to which they are entitled and there are also a number of orders passed by this Court directing steps for early handing over of possession.

On hearing learned counsel for the parties, we find that the present application is not the appropriate remedy through the applicants may have some grievance. It is for the respondents to examine whether the colony in question is to be regularized under the scheme taking into consideration the rights claimed by the applicants and the judicial orders already passed in that behalf. However, in the present writ petition, we have not passed any direction for regularization but only that the status of the petitioners would be preserved till such time as the question of regularization is finally decided by the respondents.

The petitioners have approached this Court by filing the present writ petition seeking to challenge the acquisition proceedings under the Land Acquisition Act, 1894. 





A court case WPC No. 5479/2008 regarding relief from acquisition process of khasra no. 427 is pending before the Hon'ble Delhi High Court. Stand of Department of Urban Development, GNCTD is that, the process of verification by agencies is still in progress and whether the particular unauthorized colony is eligible or not for regularization depend upon, inter alia the scrutiny report of MCD / DDA, fulfillment of conditions of notification issued by the Govt. of India dated 24-03-2008 and directions of the Hon'ble High Court and Supreme Court.

There are some other court cases also pending before the Hon'ble Delhi High Court where khasra no. 240 and 241 of Village Mehrauli are in question. There is another unauthorized colony named Shanti Kunj, Behind Sect.-D, Pocket III & IV, Vasant Kunj listed at Regn. No. 83 which include khasra no. 241 as reported by DC (South) Revenue Office. There is no report / demarcation of khasra no. 240 in this colony.

The subject matter of the meeting is proposed execution of land in khasra no. 427 of Village Mehrauli located in Shanti Kunj. Since, the process of regularization is in progress, the acquisition proceedings against land falls within the boundary of unauthorized colony at regn. no. 1144 having more than 50% buildup houses may be continues but possession of said land kept pending till the time final regularization of colony is done. A similar kind of order has been passed in the WPC No. 3705-07/06 which pertains to Samalka Extn. Copy of order dated 27.03.2009 is placed opposite (flagged).
