- (g) To receive, to have custody or and to expand the funds of the society and manage properties of the society.
- (h) To take all such other legal steps which may appear beneficial for the smooth and better management of the society.
- (i) To sue and defend all legal proceedings on behalf of the society

The reasons of termination shall be communicated to the concerned member. Every such expelled member shall have a right to appeal before the General body, which may or may not approve his appeal.

6. APPEALS:-

All the appeals shall be preferred to the general body of the society, the decision of the general body shall be final. The reason of rejection shall be communicated to the member concerned if required. This clause will be applicable to the termination clauses also.

7. RE-ADMISSION:-

The member expelled by the general body can be readmitted provided the member concerned pays all up to date dues & agree to abide by aims & objectives of the society. The decision of the general body shall be final. This clause will be applicable for termination clauses.

8. RIGHTS& PREVILEDGE OF MEMBERS:-

Every member shall have right to participate/vote in the general, body meeting, shall be entitled to inspect the records of the society with prior approval of governing body. Besides this He/She shall have also right to vote in the meetings of the society. Every member shall be entitled to participate in the meetings, functions and getogether programmes of the society, to inform the diety pertaining to any matter of the society.

9. GENRAL BO There shall be a general body of this society consisting of all the members. The meeting of the general body shall be held every one year with 1/2 Quorum. No quorum shall be required in the adjourned meeting. An emergent meeting may also be summoned on the written request of 3/4 members with ten days prior notice for such meetings. The notice period of general body shall be fifteen days. The followings business shall be

transacted in these meetings:-

(a) To prepare annual programmes and policies.

(b) To discuss and to decide all such other matters and issues which are directly or indirectly related to the affairs of the society.

(c) To pass annual budget of the society

(d) To appoint a qualified auditor who will annually audit the accounts of the society's funds.

(e) To consider any business brought forwarded and by governing body.
