
28. **ANNUAL LIST OF GOVERNING BODY :**

All cash in excess of the above amount shall be deposited in any Nationalized Bank/Banks, selected by the Governing Body Meeting.

**F) EXECUTIVE MEMBER :**

They shall assist in the day to day work of the society as directed/suggested by the Founder President/General Secretary.

**23. DISSOLUTION :**

The society needs to be dissolved it shall be dissolved as per-provisions laid down under Section 13 & 14 of the 'SOCIETIES REGISTRATION ACT OF 1860' as applicable to the National Capital Territory of Delhi.

**24. LEGAL PROCEEDINGS :**

The society may sue and/or be sued in the name of the President as per provisions laid down under Section-6 of the 'SOCIETIES REGISTRATION ACT OF 1860' as applicable to the National Capital Territory of Delhi.




The accounts of the society shall be audited by the qualified auditor (Chartered Accountant) appointment by the Governing Body, after every year.


**26. AMENDMENT :**

## **POWERS AND DUTIES OF OFFICE BEARERS & EXECUTIVE MEMBERS :**

A) PRESIDENT:

He will be head of the society and Preside-over the meetings of the General Body and Governing Body. He will have the right of casting of vote in case of tie. The President of the Society shall also enjoy the Powers and duties: -

- i) President shall summon and preside over all the Governing Body, General Body Meetings of the Society :
  - ii) In the court of any proceedings or meetings of the Governing Body or the General Body, the decision of the President shall be considered as final ( in case of dispute as to the meanings or interpretation of any Rule):
  - iii) President shall have the power to allow inclusion of any subject matter in the agenda for the discussion in the course of proceeding/meeting:
  - iv) In case it is necessary to decide any point/matter/issue urgently and there is no time to call the Governing Body Meeting. The President has the powers to decide the point/issue/matter but he/she shall bring the matter to the notice of the Governing Body as early as it is possible.

**B) VICE PRESIDENT:**

In the absence of the President, the Vice-President shall enjoy all powers and duties, which are entrusted to the President. He will also assist to the President in his work.

C) GEN. SECRETARY:

Secretary shall be the subject to control the supervision of the Governing Body, have the power to make general directions and management of the affairs relation to the society. The Secretary of the society shall also enjoy the Powers and Duties.

- Secretary of the society shall also enjoy the Powers and Duties.

  - i) Secretary will sign all the papers/letters, on behalf of the Society, to conduct its correspondences;
  - ii) To appoint/terminate such staff as may be required for effective and efficient management of the affairs of the society ;
  - iii) In the event of any office bearer(s) seat falling vacant, the powers and functions of that office bearer/executive member would vest in the Secretary of the Society.
  - iv) The Secretary will ordinarily hold a cash balance not exceeding of Rs.5,000/- (or the amount, which may be fixed by the Governing Body of the society from time to time) to meet the emergent needs relating to the society.
  - v) Secretary will get the accounts of the society audited by the Qualified Auditor appointed by the Governing Body of the Society.
  - vi) Secretary will record the minutes of the proceedings of meetings of the Governing Body and have them duly signed by the members who attend the meeting.

**15. ELECTION :**

The General Body in its annual meeting will elect its President and all the office bearers and members after Three years, by secret ballot papers. The quorum of the General Body and the Governing Body shall be 2/3<sup>rd</sup>.

**16. BRANCHES OR THE SUB-COMMITTEES :**

The Governing Body, in its meeting shall from the Branches or the Sub-Committees at over in India & Abroad. The Governing Body, from time to time, shall make the rules and General Directions for these Branches and Sub-Committees.

**17. SOURCES OF INCOME OF THE SOCIETY:**

- a) Admission Fee
- b) Subscription
- c) Donations
- d) Special Contributions

All the income of the society received from all the sources shall be utilized only for the promotion and upliftment of the Aims and Objects of the society.

**18. BANK ACCOUNT OPERATED :**

The fund of the society shall be kept in a scheduled bank or post office. The Bank account of the society shall be operated by the President, Gen. Secretary & Treasurer of the society.

**19. FINANCIAL YEAR :**

The Financial Year of the society shall start from the first day of 1<sup>st</sup> April to 31<sup>st</sup> day of March, every year.

**20. MANAGEMENT OF FUNDS :**

All the income of the society shall be deposited in the Nationalized Bank/Multinational Banks/Post office.

**21. ANNUAL LIST OF GOVERNING BODY :**

Once in every year a list of the office bearers and Executive Members (of the Governing Body/Managing Committees) shall be filed in the office of the "REGISTRAR OF SOCIETIES DELHI" as it is required/necessary under the "SOCIETIES REGISTRATION ACT OF 1860" as applicable to the National Capital Territory of Delhi.

- f) To prepare plans and programs for the upliftment of the Aims and Objects of the society.  
To receive, to have, keep in custody of and to expend the funds/moveable or immovable properties and to manage the same.
- g) To appoint, control and terminate such staff as may be required for effective and efficient management of the affairs of the society. Governing Body as a whole is liable for its return.
- h) To arrange finance, if required, from Bank(s), Institutions (or/and) Individual on reasonable terms and conditions and the Governing Body as a whole are liable for its return.
- i) Pertaining to upliftment/attainment of the Aims and Objects of the society.
- j) To accept donations, charities, loans, grants, properties etc. from the members, public, other Associations, Agencies and from Govt. or/and Semi Govt. Departments.

11. **RE-ADMISSION:**

In case, any member of the society is expelled by the Governing Body on the reason of Non payment of the subscription, he can be re-admitted, provided the member concerned pays all upto Date dues the permission of the Governing Body.

12. **APPEALS :**

All the appeals should be preferred to the General Body of the society. The decision of the General Body shall be final. The decision, of the General Body shall be communicated to the member concerned.

13. **COMPOSITION OF THE GOVERNING BODY :**

The Governing Body shall communicate to the Executive Member and the Office Bearers under:

**NOTICE:** Not less than 15 days clear notice shall be given to the members, before the Date of General Body Meetings, enclosing the agenda specifying Date, Time the plan and general nature of Business to be discussed at such meeting..

**QUORUM:** The quorum of the General Body Meetings shall be  $\frac{2}{3}$ rd of total strength of General Body members. If the required quorum is not attended in any meeting it shall be adjourned of further period of one month. At such adjourned meeting no quorum shall be required/ necessary.

**GOVERNING BODY:** The management and administration of all affairs of the present society including the management and control of all the branches or regional offices or run-up or under institute and the control and supervision of other activities taken up by society together with all its property of any nature or sort shall rest in the hands of the Governing Body.

**FOUNDER MEMBER:** The office bearers and the Executive Members of the 1<sup>st</sup> Governing Body shall be considered as the founder Member.

**STRENGTH:** The strength of the Governing Body shall not be less than 12(Twelve) and not more than 21(Twenty one).

**TERMS:** The term of every Governing Body shall be Three Years.

**NOTICE AND QUORUM:** Minimum 10 Days clear notice shall be required for the Governing Body Meeting enclosing the agenda specifying Date, Time, Place and General Natural of Business to be discussed at such governing Body Meeting.

**GOVERNING BODY MEETING:** Governing Body Meeting shall be held on March of every year (or as and when the Governing Body may decide). *M.L.*

**QUORUM OF THE MEETING:** The quorum of every Governing Body Meeting shall be  $\frac{2}{3}$ rd (two third) of the total strength of Governing Body.

10. **FUNCTIONS & POWERS OF GOVERNING BODY:**

- a) The Governing Body shall responsible for the management and administration of the affairs of the society. The Governing Body is authorized to appoint any member to look after any particular matter/function/institute of the property of the society.
- b) All the decisions shall be taken by the majority votes of the office bearers and the executive members present in case of the votes evenly divided the President shall have the power to use the casting vote.
- c) Any person/persons, member/members, execute all agreements and contracts and sign bonds as well as receipts or legal documents on behalf of the society.
- d) The Governing Body may appellant 'Honorary Patron' or and patrons.
- e) The Governing Body shall have all powers as not powers of the society mentioned in the memorandum of the society and these Rules & Regulations. The Governing Body shall have also the following.

- g) If he/she has not attended three consecutive meetings without proper intimation to the President of the Society.
  - h) If he/she disregards the Rules & Regulations or the decisions of the Governing body of deliberately violates the directions of the President/Governing Body.
  - i) If 1/3rd or more than seven members of the society make a written complaint against any member, the Governing Body of the society is authorized to take the decision of termination of such member from the membership of the society.

**NOTE:** 1) The reason of termination/cessation from the membership of the Society shall be communicated to the member concerned.

2) A member expelled from the membership of the society, shall have no right to enjoy the 'Rights & Privileges' mentioned in clause No.6 of these Rules & Regulations.

**6. RIGHT AND PRIVILEGES OF MEMBER :**

*All and every member of the society*

- a) Have no vote at every meeting.
- b) Shall be entitled to participate in the meetings, cultural or/and religious functions and other lawful gatherings, called /arranged by the above society.
- c) Have right to collect the Identity Card (Duly Signed by the President and Secretary) after depositing the required/prescribed fee (~~fixed by the Governing Body~~).
- d) Have right to inspect the books and proceeding/minutes the society with the permission of the President and Secretary.

**7. DUTIES OF THE MEMBERS:**

*All and every members of the society shall:*

- a) Administer of the office and loyalist to the society and/or its Constitution to the President.
- b) Elect the Governing Body of the society.
- c) Attend the general body meetings.
- d) Give the necessary information's to the society pertaining to any matters which in necessary to be known by the society.

# RULES & REGULATIONS

## 1. NAME OF THE SOCIETY :

The name of the society shall be: "**RESIDENT WELFARE ASSOCIATION (BLOCK-II/I/J & M)- SANGAM CHOWK-WEST SAGAR PUR**"

## 2. DEFINITIONS:

'Rules and Regulations', unless there is any thing repugnant in the subject or context.

The Society means - "**RESIDENT WELFARE ASSOCIATION (BLOCK-II/I/J & M)- SANGAM CHOWK-WEST SAGAR PUR**"

The 'Governing Body' means - The Governing Body/Executive Committee or the managing committee of the society.

- i) The 'General Body' means - The General Body of the Society.
- ii) The 'Executive Member' Means: - The member of the Governing Body.
- iii) The 'Member' Means: - The member of the General Body/Society.
- iv) The 'Patron' Means: - The Patron of the Society.

## 3. MEMBERSHIP:

The membership of the society is open to any person who has attained the age on maturity and fulfils the terms & conditions of the society but the subject to the approval of Governing Body and no admission fees payable those who has handicapped and poor person.

**NOTE:** The reason of refusal for the membership shall be communicated to the Person/applicant concerned.

## 4. ADMISSION FEE & SUBSCRIPTION:

The Admission Fee and the Subscription shall be as under unless otherwise revised by the Governing Body of the Society.

- a) Admission Fee Rs.500/- (Five Hundred Only) at the time of admission for life.
- b) Subscription Fee Rs.500/- (Five Hundred Only) Per Annum.

## 5. TERMINATION OR CESSION OF MEMBERSHIP:

The Governing Body of the Society shall have the powers to expel/terminate members and members from the membership of the above society on the following grounds:-

- a) On his/her death.
- b) On his/her written resignation.
- c) If he/she is found to be involved in any Anti-Social activity.
- d) If the Governing Body finds him guilty by means of Anti Propaganda of the activities of the society.
- e) If he/she is adjudged by a competent court of law to be a criminal offender or unsound mind.
- f) If he/she fails to pay the subscription of contributions for three months from due date.


- i) To accept donations, grants, presents, gifts, and other offering (in the shape of moveable or immovable properties) and objects of the above society.

- iv) To receive grants, loans, advances or other money on deposit or otherwise from the Central Govt./State Govt. Banks, Societies, Trust or Individuals with or without allowance of interest thereon.
- v) To do such other things/acts/activities, which are, necessary and which may be incidental or conducive to the attainment of any of the objects of the society.
- vi) All the incomes, earnings, moveable/or immovable properties of the society shall be solely utilized and applied toward the promotion of its aims and objects only as set forth in Memorandum of Association and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever to the present or past members of the society or to any person claiming through anyone or more of the present or the past members.
- vii) To society will invest its money and funds according to section 11(5) of the Income Tax Act, 1961.


