- (a) shall be entitled to participate in meetings, cultural/educational functions and other lawful gatherings, called/arranged by the society,

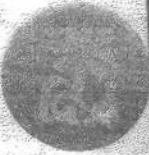

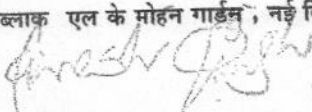

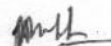
