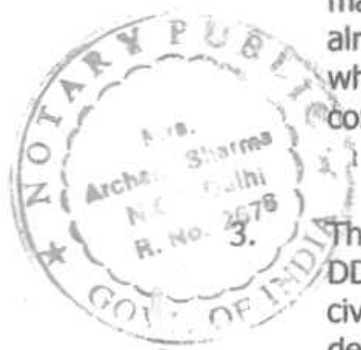

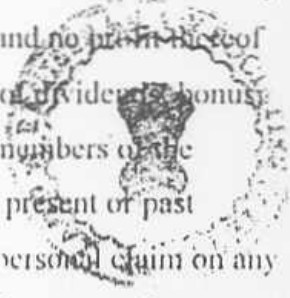
3. **Aims and Objects**

- (ii) The decision of the Board of unauthorised colonies held on 14.07.2009 and order dated 01.09.2009 shall be strictly followed.
- (iii) The work shall be carried out only in the layout plans as available in the record against the concerned unauthorised colony.
- (iv) That the work shall be completed strictly in accordance with the specification given in the estimates. No variation in the specification will be done without prior approval of Pr. Secretary (UD).
- (v) It must be ensured by the implementing agency that the sewer line has not been laid earlier.
- (vi) That the work shall be completed in stipulated period given in the estimates.
- (vii) That the monthly progress report for each work and expenditure shall be furnished to Pr. Secretary (UD) for his appraisal
- (viii) That the codal formalities shall be complied with as are required as per the General Financial Rules and CPWD manual.

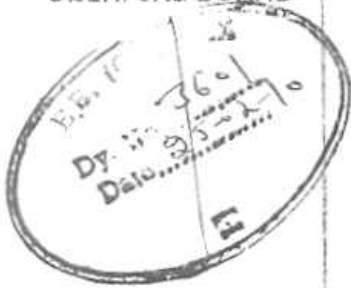
