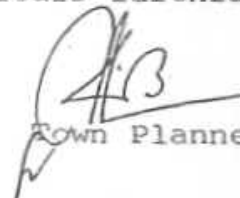
Sir,

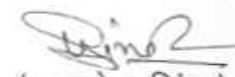

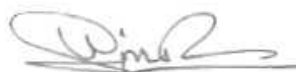
