I am directed to refer to your letter No. CMO/PGC (E)/2009/150448 dated 20.10.2009 along with the representation of Shri Mukund Lal, President, Jan Kalyan Samiti, Panchsheel Vihar, Malviya Nagar, New Delhi regarding release of funds from UD Deptt. for development works i.e. laying of water line and sewerage line in Panchsheel Vihar, Malviya Nagar.

As per the report of Forest Deptt., this colony is mentioned as may be part of morphological ridge. Also as per report of ASI this colony falls in prohibited area. The same has been conveyed to you vide letter No.1220/UC/UD/2008/17943 dated 10.11.2009 (Copy enclosed). Regarding submission of maps again by RWA, the issue has been raised by Town Planning Deptt. of MCD. You are requested to approach MCD for clarification.

Therefore, development work can not be taken up in this unauthorised colony at present.
