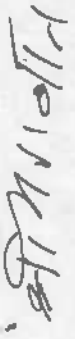

The reasons of termination shall be communicated to the concerned member. Every such expelled member shall have a right to appeal before the General body, which may or may not approve his appeal.

6. APPEALS:-

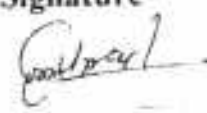

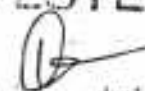

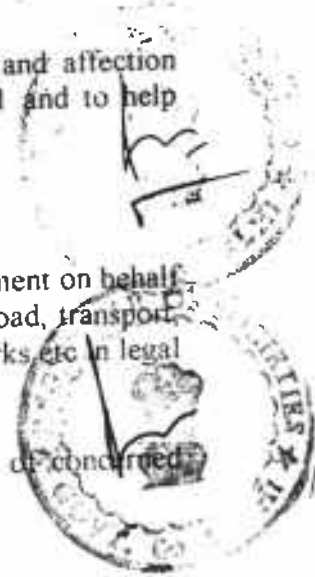

POWER AND DUTIES OF THE OFFICE BEARERS:

16. FINANCIAL YEAR: The Financial year of the society shall start from 1st April to 31st March of every year.
