- h. To sue and defend all legal proceedings on behalf of the society.
- i. To take all such other legal steps which may appear beneficial for the smooth and better management of society.

viii. Executive members..minimum 14 and maximum 24

6. APPEALS :-

All the appeals shall be preferred to the general body of the society, the decision of the general body shall be final. The reason for rejection shall be communicated to the member concerned.

7. RE-ADMISSION:-

In case of member expelled by the general body the same can be readmitted provided the member concerned pays all upto date dues. The decision of the general body shall be final.

8. RIGHTS & PRIVILEGE OF MEMBERS:- Every member shall have right to participate in the general body meeting and shall also be entitled to inspect the record of the society with prior approval of governing body. Besides this he/she shall have also right to vote in the meetings of the society. Every member shall be entitled to participate in the meetings, functions and get-together programmes of the society.
