**RULES AND REGULATIONS OF RESIDENTS WELFARE ASSOCIATION of

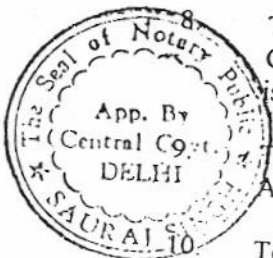
1. Name of the Association: The name of the Association shall be RESIDENTS WELFARE ASSOCIATION OF VIPIN GARDEN EXTENSION.
