- (i) That the nominees for election, their proposer and the seconder are bonafide members of the Association. If after the election disqualification are discovered, the elected member shall automatically stand debarred from the office.
- (ii) There are any areas of subscription or any outstanding dues in his name no such member be entitled to election ; and
- (iii) There is any criminal case pending against him/her in the court of law or he/she has been convicted of a criminal offence, no such member be entitled to the elections; and
- (iv) If a member has been adjudged insolvent and under a notice from the authority (i.e. DDA or Association) for illegal/misuse and/or acquisition of the common lands and services of the

Election of the Officers

- (i) To specify the time at which and the manner in which annual general meetings and special meetings of the associations shall be held.

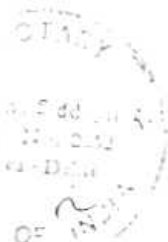

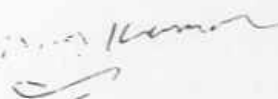

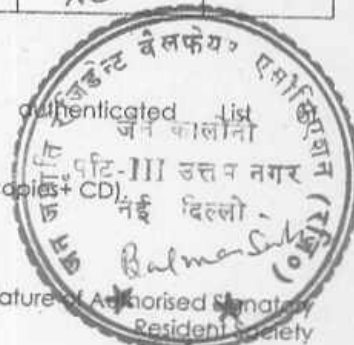
