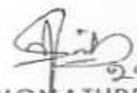

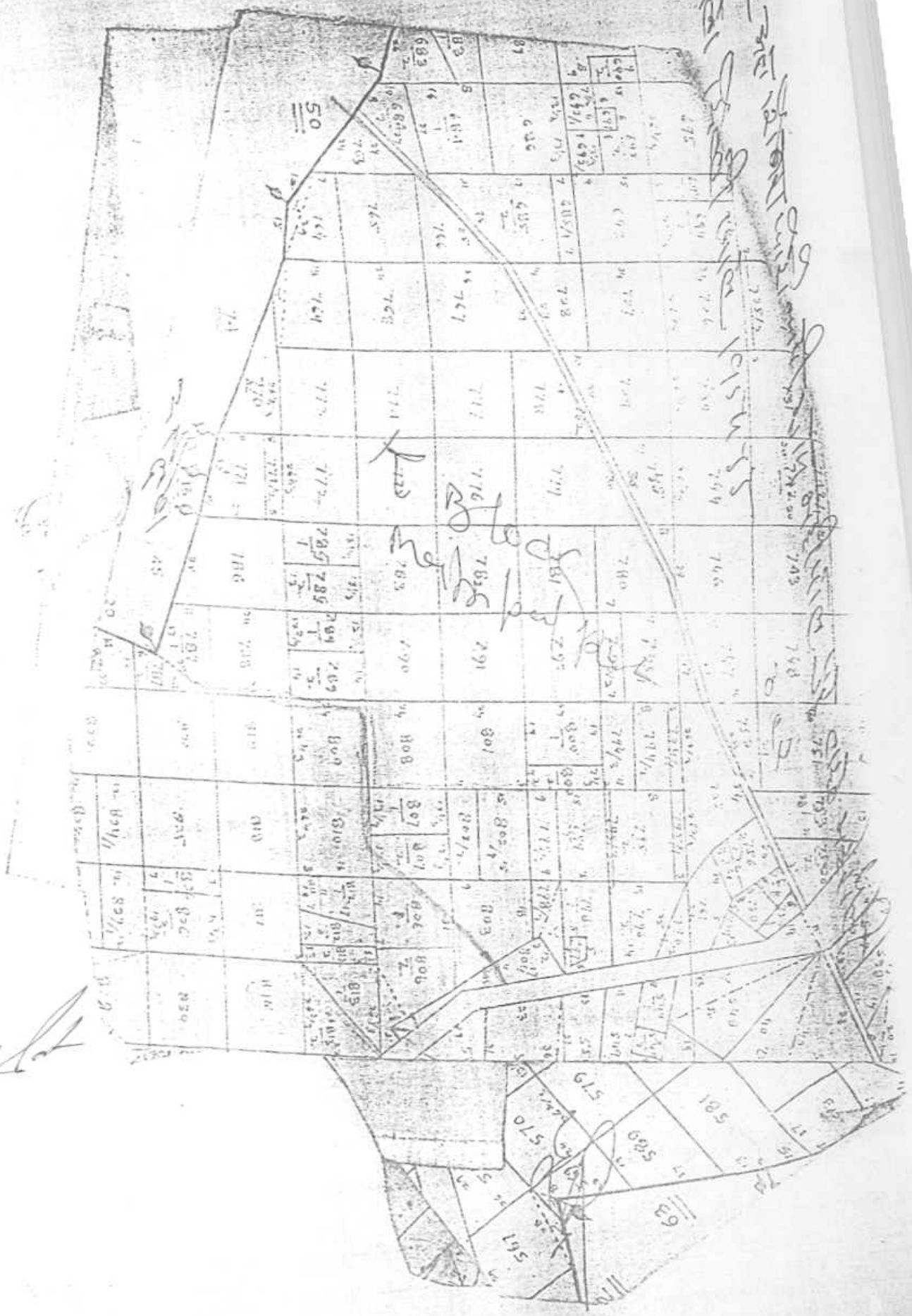

(i) As per the decision of the Cabinet dated 20.11.07, as far as possible, the cement concreting roads in unauthorized colonies be done where water lines or sewer lines or any other services are to be laid thereby obviating the need to frequently cut the roads.

(ii) The works shall be carried out only in the layout plans as available in the record against the unauthorized colony.

(iii) DSI IDC shall ensure that the amount spent does not exceed the budget amount allocated to it for the current financial year 2008-09.

(iv) The work shall be undertaken strictly as per the policy of GNCTD and in the manner consistent with the order of the Hon'ble High Court of Delhi in CWP
