
Sir,

Please refer to letter No. RWA/DH-1/2008-09 dated 16.3.09 on the above subject (delivered in your office vide Dy. No.15110 dated 17.3.2009 (copy enclosed for ready reference). Sir, once again, I want to bring to your kind notice that we have submitted the layout plan of our colony on 28th January 2008 before the stipulated date of 31st January (as per your Notification). Inadvertently, the registration number 1463 was given to us was of other colony and we could not show the papers to the officers in the meeting called by you and after scrutiny, our papers were found merged in the file of Registration No.1403 of Dharampura H&I Block.
