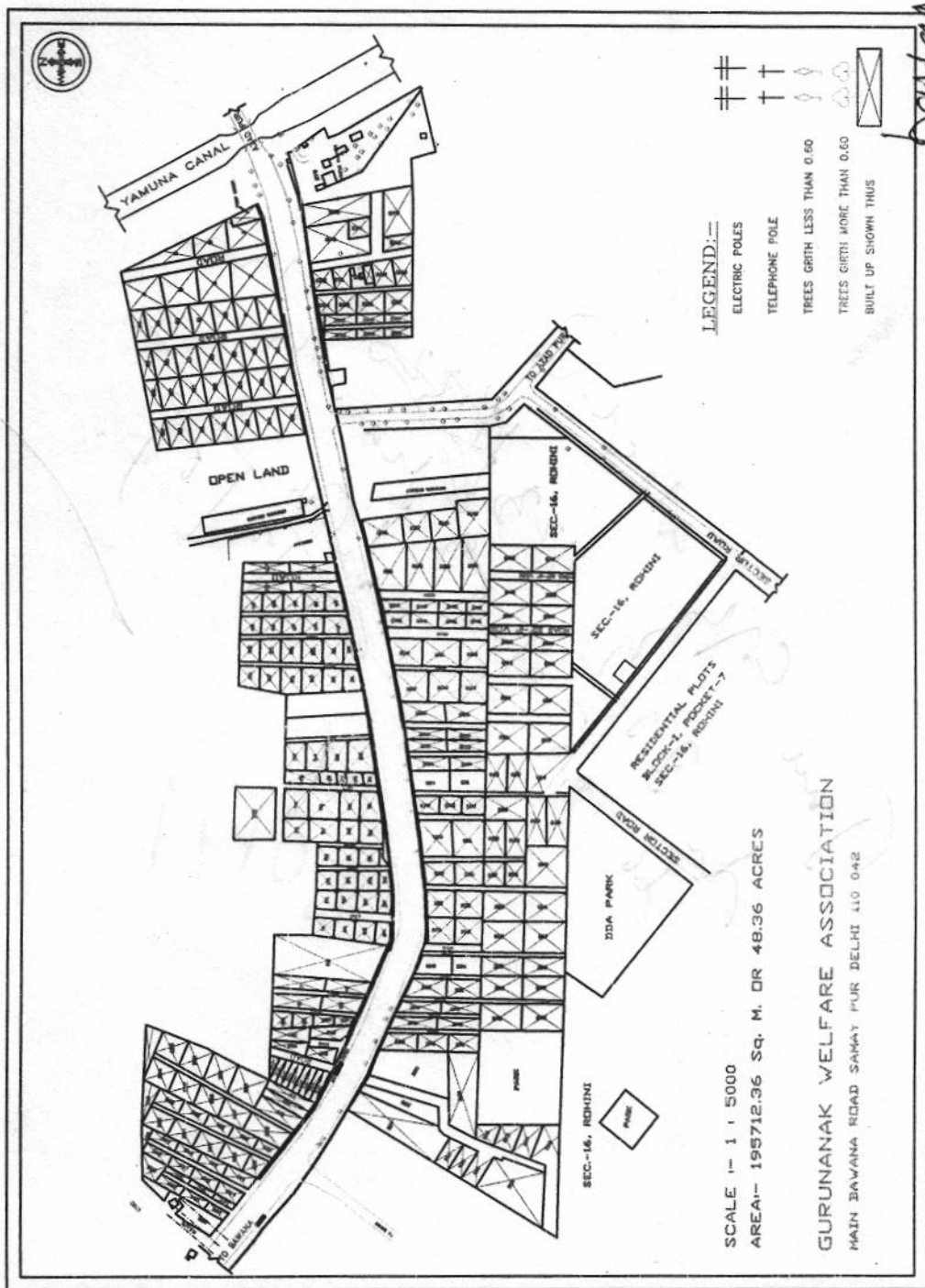

directions that it would be appropriate if the Union of India notifies colonies which according to it are required to be regularized and which cannot be regularized in terms of general principles, in particular para 11.1 of the guidelines. It was further directed that till the modalities in terms of the guidelines are worked out, interim orders passed in the writ petition shall be operative. The Division Bench gave a disclaimer, in that, it was recorded in the order that the directions would not be construed as if the court has expressed any opinion about the legality or otherwise of the guidelines. Affidavit in other records that the guidelines were circulated to the Government of NCT Delhi on 4.4.2001 for its response. It is further stated that suggestions/ representations were received from certain quarters. On 8.2.2002, a committee was constituted to examine the guidelines so as to suggest modifications/amendments required, if any. It is stated that recommendations have been received and on 4.2.2004 revised guidelines have been approved.

5. Counter affidavit filed by DDA records that as per the revised guidelines, issue of regularization of unauthorized colonies in Delhi is being considered by the authorities.

6. In view of the counter affidavit filed, no directions can be issued. As and when a final decision is taken by the authorities and if name of the petitioner's colony is excluded

1. Rule. Heard for disposal.
2. Prayer made in the writ petition is that respondents be directed to regularize the colony Shahbad Extension, Samaypur.
3. As per counter affidavit filed by the Union of India, it is stated that in a Public Interest Litigation filed by Common Cause being WP(C) No.4771/1993, vide order dated 13.10.1993, this court restrained the government from regularizing any unauthorized colony in Delhi till further orders.
4. Thereafter, matter was considered by the Division Bench from time to time. On 18.7.2000, Union Government approved the terms and conditions for regularization of unauthorized colonies. In view of court proceedings which required guidelines to be prepared, guidelines were settled and were filed in the said writ petition on 20.2.2001. Vide order dated 27.2.2001, the writ petition was disposed of with the
