

#### 28. Source of Income:

For the purpose of raising the finance and fund the Society shall receive, hold, accept, use any fees, contributions, bequests, donations, grants of moneys, gifts, assistance and/or endowments or the proceeds of from local source(s) and donor agencies in India or abroad.

#### 29. Income:

The income of the Society, whensoever derived, shall be applied solely towards the promotion of the objects of the Society as set out in the Memorandum of Association and no portion thereof will be paid or transferred directly or indirectly, by way of dividend, bonus or otherwise as profits to the members of the Society PROVIDED that nothing herein contained shall prevent payment in good faith of reasonable and proper remuneration for services rendered or reasonable interest on money lent or reasonable rent for any premises let.

#### 30. Annual List to be filed with Registrar:

Once in every year on or before the fourteenth to be filed day succeeding the day on which the Annual General Meeting is held, a list shall be filed with the Registrar or Societies for the Jurisdiction of Delhi of the names, addresses and occupations of the members of the Governing Body then constituted as per Section-4 of the Societies Registration Act, 1860.

#### 31. Minutes:

The General Secretary shall cause to be entered minutes of the General Meetings and meetings of the Governing Body and Sub-Committees in the books kept for the purpose.

#### 32. Law Suits:

The Society may sue or be sued in the name of the President as per Section 6 of the Act.

#### 33. Alterations and Amendments:

- 33.1. Whenever it shall appear to the Governing Body that it is advisable to change the name of the Society or to alter, extend or abridge the purposes or purposes for which the Society has been formed or to amalgamate the Society, either wholly or partially with any other Society, the Governing Body shall submit its proposition to the Members of the Society and shall convene a Special Meeting for the consideration thereof but no such proposition shall be carried into effect unless the procedure in Sections 12 and 12A of the Act is compiled with.
- 33.2.The Rules and Regulations of the Society and other matters in the Memorandum not provided for in Rule 33.1 above may be amended at a General Meeting by passing a resolution by simple majority.

#### Annual General Meeting: 22.



- 22.1. The Annual General Meeting of the Society shall be held within six months from the close of the financial year of the Society. A notice of twenty one clear days for the holding of such meeting shall be sent by ordinary post to all the Members and Representatives at the address(es) registered with Society along with a statement of business to be transacted thereat and the time and place where such meeting is to be held. The notice period aforesaid may be waived by all the members and Representatives for the time being present in India.
- 22.2. At the Annual General Meeting, apart from any other business set by the Governing Body, the following business shall be transacted:
  - i) consideration and adoption of balance sheet and the audited account of the Society;
  - ii) consideration and adoption of the Annual Report of the Governing Body regarding the working of the Society;
  - iii) consideration and approval of the budget for the following
  - iv) election as per rules of the members of the Governing
  - v) appointment of Auditors of the Society.

#### 23. Quorum:

The quorum necessary for a General Meeting shall be five members or two-third of the total number of members entitled to vote, whichever is higher, present in person.

24. Election:

#### N.7. Alternates:

- 17.1.If any member of the Governing Body shall be likely to remain outside India for a period not less than three months, an alternate for such member of the Governing Body may be appointed by the Governing Body.
- 17.2. An alternate so appointed shall not hold office as such for a period longer than that permissible to the original member in whose place he has been so appointed and shall vacate office if and when the original member returns to India.

#### 18. Power to make Byelaws:

The Governing Body may, in respect of any matters not hereby expressly provided for make such Byelaws from time to time with regard to the conduct of the business or management of the affairs of the Society as it may think proper or necessary with power to add, after, amend, abridge, substitute, or delete any provisions of such By-laws.

#### 19. Meetings of Governing Body

- 19.1. The Governing Body shall hold meetings at least four times in a year or at such earlier intervals as may be necessary and shall be convened by the President. The Governing Body may adjourn or otherwise regulate its meetings and proceedings as it may think fit.
- 19.2.At least 7 days notice of the time and place shall be given for a meeting of the Governing Body, but a meeting may be called at shorter notice if the members thereof for the time being in India unanimously agree to waive the aforesaid period of 7 days.
- 19.3. At least two members including President, Secretary or their alternates shall constitute in quorum for a meeting of the Governing Body.
- 19.4 The Governing Body shall take decisions by majority vote and every member shall have one vote. The President or his alternate shall preside and in case of equality of votes, shall have a casting vote.
- 19.5.A resolution signed by three-fourth majority of the members of the Governing Body after circulation amongst all the members shall be as effective and binding as a resolution passed by a meeting of the Governing Body.

#### 20. Sub-Committees:

The Governing Body may select some of themselves to form Sub-Committee with such duties and powers as may be assigned and subject to such rules of procedure as may be laid down by the Governing Body.

#### 21. General Meeting:

In addition to any other General Meetings the Society shall hold each year an Annual General Meeting of the General Body of the Society. The Secretary shall be an ex-officio member of the General Body.

- (xv) To appoint, dismiss and reappoint all staff of the Society;
- (xvi) To enter into, defend and compromise litigation of all kinds
- (xvii) To invest any monies or funds of the Society in such manner as the Governing Body may from time to time determine without any profit making purposes;
- (xviii) To establish trusts whether for the benefit of the employees of the Society or otherwise for the objects of the Society;
- (xix) To pay, settle and/or disburse expenses, fees, costs for implementing the objects of the Society

#### Cessation of Membership of Governing Body:

The office of a member of the Governing Body shall fall vacant if a member:

- i) dies, or voluntarily resigns his office;
- ii) becomes incapacitated by reasons of illness, lunacy or insolvency or if he is indicted for an offence involving moral turpitude;
- iii) remains absent from three consecutive meetings of the Governing Body without obtaining prior leave of the President;
- iv) being a Representative, he is removed from the Governing Body by the Member which he represents or such Member ceases to be a member of the Society.

#### 16. Filling of Vacancies in Governing Body:

In case the office of a member of the Governing Body is vacant for whatever reason, it may be filled in the by Governing Body till the next Annual General Meeting.

- (viii) To undertake projects entrusted by and/or to work in close collaboration with Government. Semi-Government, or other bodies or persons having the same objects as of the Society and/or for promoting or supporting any activities of Government, semi-government educational and/or charitable or similar institutions operating in similar fields;
- To organise, funds, promote and encourage, exhibitions, fairs, seminars, lectures. film shows etc. and to publish and distribute without any profit motive, journals, periodicals, newsletters. pamphlets, books, booklets, etc. and other modes of mass communication including audiovisual modes:
- To receive, use, hold, accept and apply any fees, contributions, bequests, donations or (x) endowment or the proceeds thereof for carrying out the objects of the Society;

- 9.1. The President of the Society will be elected by a majority of votes after every five years, so long as possible from amongst the Founder Members and thereafter from the individual-voting members of the Society.

#### 10. General Secretary:

- 10.1. There shall be a Secretary of the Society who will be elected by a majority of votes after every five years.
- 10.2. The Secretary shall be the Chief Executive of the Society and shall have all powers of management of the affairs of the Society.

#### 11. Assistant Secretary:

#### 12. Treasurer:
