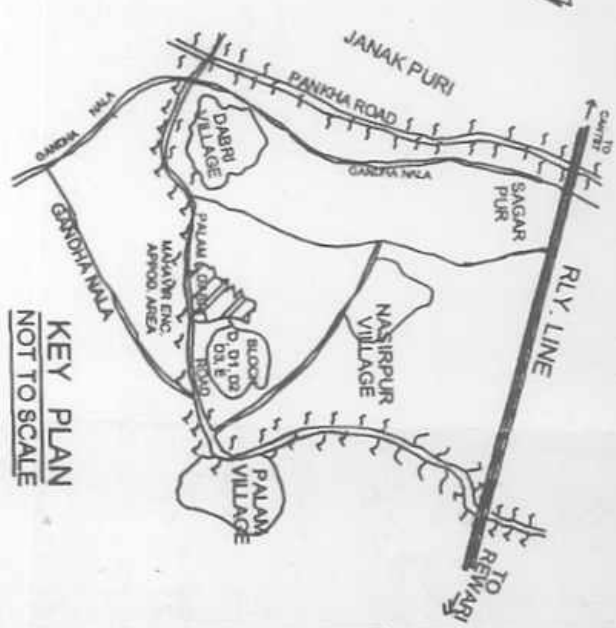

 - vi) To open, found, establish, promote, set-up, run, maintain, assist, finance, support and help the various community development (programs/activities and also construct and develop the Community Halls, Marriage Homes, Dharamshalas, Night -Shelters, Shochalaya, Old Age Homes, Orphanage, health Care Centers, Charitable Dispensaries, Hospitals, Libraries, Reading Rooms, Play grounds, Stadiums (both open and indoor), Yashwantrao Chavan Pratishthan, Gymnasiums, Sangeetalyas & Nrityalayas (music and dance training center), Balwars, Mahila Ashrams, Studios, Drama, Stage and other buildings for the benefit of the General Public and for the welfare of the general public.
