20. DISSOLUTION :

Members not less than three fifths of the total members of the Society may determine that it be dissolved and thereupon the Society shall be dissolved forthwith for at such time agreed upon in accordance with the procedure laid down in Section 13 & 14 of the Societies Registration Act, 1860.

If upon the winding up or dissolution of the Society there remains after satisfaction of all debts and liabilities, any property whatsoever, the same shall not be paid to or distributed among the members of the Society but shall be given or transferred to some other Society or Societies having objectives similar to that of the Society and which prohibits or prohibit the distribution of its or their income among its or their members to an extent at least as great as is imposed on the Society under or by virtue of Rule hereof and it and in so far as effect cannot be given to the aforesaid by the members by a resolution of a General Meeting.

21. APPLICATION OF THE ACT

All the provisions under all the Sections of the Societies Registration Act of 1860, as applicable to National Capital Territory of Delhi, shall be applicable to this society.

- c) Once at least in every year, the accounts of the Society shall be examined and the correctness of the balance sheet ascertained by one or more qualified auditor or auditors.

15 SEAL :

The Governing Body shall provide common seal for the purposes of the Society which shall be kept under safe custody and control as the Governing Body shall from time to time determine. The seal of the Society shall not be affixed to any instrument except pursuant to a resolution of the General Body who shall sign every such instrument to which the seal is affixed in their presence : every such instrument shall be countersigned by the Secretary.

16 CONSENT BY CIRCULAR :

In case of emergency the President can direct the Secretary to circulate any proposal for the opinion of the members giving a weeks time for the receipt of the opinion from the date of dispatch of the proposal. If no dissent to the proposal contained in such circular, is received within the stipulated period the proposals shall be deemed to have been passed provided at least on third members of the Governing Body have noted in writing for the proposal. All decisions taken by circular, should be forthwith reported in writing to all members of Governing Body. All questions put to vote at the meeting shall be decided unless otherwise provided for by a simple majority the Chairman having the right of a casting vote.

17 SUITS BY AND AGAINST THE SOCIETY :

The Society may sue or be sued in the name of the President as per section 6 of Societies Registration Act, 1860.

Provided that it shall be competent for any person having a claim or demand against the Society to sue the President or Secretary or a member of the Governing Body, thereof, on an application to the Governing Body, some other officer or person be nominated to be defendant.

Every year a list of the Governing Body shall be filed with the Registrar of Society as laid down in Section 4 of Societies Registration Act, 1860.

18 AMENDMENTS :

The Memorandum of Association of the Society and its Rules and Regulations hereafter made by the Society or by the Governing Body may from time to time be modified, added to, revoked or enacted by a majority of not less than $\frac{3}{5}^{\text{th}}$ of the members of the Society present at a General Meeting called for the purpose provided that in case of any alteration, abridgement, additions to the purpose of the Society, or its amalgamations with another Society or the change of the name of the Society provision of Section 12 of the Societies Registration Act, 1860, shall apply.

19 REMUNERATION AND REIMBURSEMENT OF EXPENSES TO THE GOVERNING BODY MEMBER OF THE SOCIETY :

Any Governing Body Member acts or devote his full time in the office or render special services either in the capacity of President, Secretary, Vice-President, Treasurer or as a member, he/she should be remunerated reasonably. He/she should be reimbursed for the expenses incurred by him/her for the work undertaken on behalf of the Society.

- b) The President of the Governing Body or the Secretary may, whenever they deem fit, and the President or the Governing Body shall on requisition made in writing and signed by seven or more members of the Society stating the purpose of the meeting convene an extra-ordinary General Body Meeting at any time and for any purpose whatsoever provided that such purpose does not conflict with any matters already dealt with at the immediately preceding General Body Meeting.
- c) An Annual General Meeting or Extra-ordinary General Meeting shall be called by least 15 days clear notice in writing provided that where the matter to be considered is in the opinion of the Governing Body or of the Secretary an urgent one. A short notice may be given.
- d) The accidental omission to give notice of a meeting, of the non-receipt of notice of a meeting by any person entitled to receive such notice shall not invalidate the proceedings at the meeting.
- e) No business shall be transacted at any General Meeting except the adjournment of the same to a future date and place unless a quorum of one third of members be present in person or by proxy when the meeting proceeds to business.
- f) At any general meeting, every member shall have one vote. A member entitled to vote in person shall be entitled to vote by proxy.
- g) The Quorum for the General Meeting shall be one third of the members.

12 MINUTES AND RECORDS :

The Secretary together with the Treasurer shall prepare and keep a record of the proceedings of every General Body Meeting and the Meetings of the Governing Body in a book or books to be kept for the purpose. Such minutes if signed by the Chairman of that or of the next following meeting, when so recorded and signed, shall be receivable in evidence of the proceedings therein recorded without further proof. If so deemed required the Governing Body may appoint a Deputy Secretary or Assistant Secretary.

13 FUNDS AND ACCOUNTS :

- a) The Secretary/Treasurer together with the President shall have charge of all monies belonging to the Society and their receipt shall be discharge for all monies payable to the Society. Together with the Secretary they shall have such powers as listed in Rule above and shall cause true accounts to be kept of the assets, credits and liabilities of the Society. If so deemed/required the Governing Body may appoint a Deputy Treasurer or Assistant Treasurer.
- b) A Bank Account or Bank Accounts shall be opened in the name of the Society and all the cheques thereon shall be signed by the Secretary/ Treasurer and the President.

14. AUDIT :

- a) The Financial year of the Society shall be the financial year that is from 1st April to 31st March of each year.
- b) Auditor or Auditors shall be appointed as per the directions of the General Body and their duties regulated in accordance with the requirement of the Society as determined by the Governing Body.

FUNCTIONS AND POWERS OF THE TREASURER

- a) The Treasurer shall be the Chief executive of the Society and shall also be responsible for the functioning of the Society within the scope of the Memorandum of Association, the Rules and Regulations for the time being in force, and the policies laid down by the governing body and the General body.
- b) The Treasurer shall be responsible for the account opening of the association and its accounting etc.
- c) The Treasurer shall also be responsible for getting the accounting of the association done from the auditor.
- d) The Treasurer shall also be responsible for the day to day accounting of the association and shall submit periodical accounts/ reports to the governing body for approval/perusal.
- e) The Treasurer shall disburse, invest, spend or otherwise utilize the funds and property of the Society in a smooth and efficient manner and maintain the true and proper accounts of the same, provided always that such disbursements, investment, spending or utilisation is within the scope of the Memorandum of Association, the Rules and Regulations for the time being in force, and within the policies laid down by the General Body and the Governing Body.

GENERAL BODY MEETING :

- a) The Society shall in each year hold a General Meeting for all its members at its Annual General Body Meeting in addition to any other meeting in that year and shall specify the meeting, as such in the notices calling it. Not more than 15 months shall elapse between the date of one Annual General Body Meeting and that of the next of the Society. The Annual General Body Meeting shall be held at such place as the Governing Body Meeting and shall be convened for the following purpose.

8. FUNCTIONS AND POWERS OF THE PRESIDENT

- a) The President shall be the Chief executive of the Society and shall be responsible for the functioning of the Society within the scope of the Memorandum of Association, the Rules and Regulations for the time being in force, and the policies laid down by the governing body and the General body. His expenditure power shall be upto Rs. 2000/-.
- b) The President can make ad hoc appointments of office staff which in turn would be put before the Governing body for confirmation.
- c) The President shall supervise the Secretary as well as the Treasurer in their functioning.
- d) The President shall have the casting vote in event of tie in the voting in the governing body meetings.

9. FUNCTIONS AND POWERS OF THE HONORARY SECRETARY (SECRETARY)

- a) The Secretary shall be the Chief executive of the Society and shall also be responsible for the functioning of the Society within the scope of the Memorandum of Association, the Rules and Regulations for the time being in force, and the policies laid down by the governing body and the General body. His expenditure power shall be upto Rs. 500/-.

4. TERMINATION OF MEMBERSHIP:

- a) A member may resign from Membership by giving the Secretary not less than fourteen clear days notice in writing of his/her desire to resign. The membership of the Society shall be considered terminated on the death of a member or on a member becoming of unsound mind or on the member being continuously absent from the country for a period exceeding three years.
- b) Any member who shall fail in the observance of any Rule and Regulation of the Society or any lawful by-law, regulations or order of the Governing Body or who, after investigations by the Governing Body and on such grounds and evidence as the Governing Body may consider sufficient shall be held to have been guilty of any dishonorable act, practice of conduct, may be excluded from the membership of the Society by resolution passed by a majority of at least two third of the members present and voting at General Body Meeting. Such members shall have seven clear days notice of time and place of an intended investigation sent by registered post, addressed to his/her last known place of business or to the address furnished by him/her in accordance with these Rules & Regulations and shall be entitled to attend the Governing Body Meeting and hear the charges and evidence against his/her and to make any statements and/or adduce any evidence in rebuttal of the charges against him/her.

5. MANAGEMENT:

- a) The management and control of the Society shall vest in the Governing Body of the Society. The Governing Body of the Society shall comprise of a President, a Secretary, a Treasurer and one Vice President, as Ex-office members. The minimum strength shall be seven.
- b) The members of the Governing Body shall be elected at the General Body Meeting by Secret Ballot. The Governing Body shall appoint the Secretary from among the members of Society.
- c) The members of the Governing Body shall hold office for a period of 3 years at a time and that period shall end always with the conclusion of an Annual General Body Meeting.
- d) Any of the office bearers including the Secretary may at any time on fourteen days notice in writing to the Governing Body, resign from office, provided that he/she shall be deemed to be responsible for his/her office till he/she has handed over charge to the Governing Body or to his/her duly appointed successor.
- e) If by reason of death, resignation or otherwise, any office, including that of Secretary becomes vacant during any year, such other member as may be selected by a majority of the Governing Body, shall hold office for the remaining period.
- f) The Governing Body shall have full power to act-not with standing any vacancy that may not have been filled up.
- g) The offices of the President, Honorary Secretary and Treasurer shall be filled by election at the General Body and shall carry no reward or remuneration as such, provided that nothing herein contained shall prevent payment for services actually rendered by any of the office bearers, other than those in execution of their office and such services must have been rendered at the specific request in writing of the Secretary of the Society.

1. Name: The name of the Society is 'ANAND VIHAR, GURPREET NAGAR R BLOCK WELFARE ASSOCIATION'.

2. Interpretation: In these Rules and Regulations unless repugnant to or inconsistent with the content, words and expressions shall have the following meaning:

- a) The Society means the Society established under the Memorandum of Association of the Society, with its present address at RZ-29, Gali No. 4, Gurpreet Nagar, Uttam Nagar, New Delhi 110 059.
- b) The Governing Body means the Governing Body of the Society duly constituted as provided for by the Rules and Regulations of the Society.
- c) The General Body means the General Body as constituted under these rules.
- d) The President means the President for the time being of the Society and includes his/her deputy or assistant appointed under these rules.
- e) The Secretary means the Secretary/ Honorary Secretary for the time being of the Society and includes his/her deputy or assistant appointed under these rules.
- f) The Vice President means the Vice President for the time being of the Society and includes his/her deputy or assistant appointed under these rules.
- g) The Treasurer means the Treasurer for the time being of the Society and includes his/her deputy or assistant appointed under these rules.
- h) Special Resolution means a resolution passed by the majority of not less than three fourth of the members of the Society present at the General Meeting called for the purpose.
- i) Words imparting the singular numbers shall be deemed to include the plural and vice versa.

3. MEMBERSHIP

- a) The subscriber to the memorandum of Association and all such persons as the governing body may from time to time admit to membership, shall be members of the Society.
- b) Application for membership shall be proposed and seconded by two members of the Society enjoying their full rights of membership under the Rules and Regulations of the Society for the time being in force.
- c) The Governing body may refuse to admit to membership any person without assigning any reason for the refusal, provided that in case of such refusal the Governing body shall intimate the two members concerned, of such refusal within a maximum period of ten days from the date of the resolution of refusal and the members concerned shall have the right to call within a period of thirty days of receipt of such intimation an extra-ordinary General Body Meeting to decide on the issue.
- d) Every person who being eligible for membership shall pay Rs. 200/- as admission fees and Rs. 20/- as the monthly subscription. Any such person, if he/she makes default, in paying the said sum of or any part of subscriptions, his/her name shall be removed from the Register of Membership of the Society.
