





C. GENERAL SECRETARY

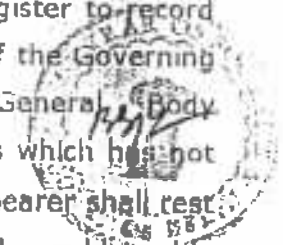
1. General secretary will summon and attend the meeting of the governing Body and the General Body.
