

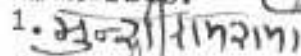
Whereas the Government as per the press release has required from the association of Delhi Residential Welfare association for the regularisation of the Colonies which were previously declared as unauthorised colonies.

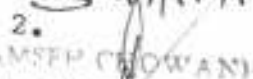
Now notwithstanding anything contained in this indemnity bond, it is resolved :-
