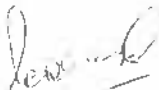

In this context, it is also pointed out that the Government has not initiated development charges from people in unauthorised colonies and that public money was being spent

According to CIDA officials, they have not been informed about the work being done by the DSD. The Central Government is proposing to regulate over 1,000 unauthorised colonies, which came into existence within the city limits prior to March 1993. The draft bill, which contains the basic terms and conditions for regulating the unauthorised colonies, has already been approved by the Urban Development Ministry about four months ago. The complete guidelines are yet to be finalised.

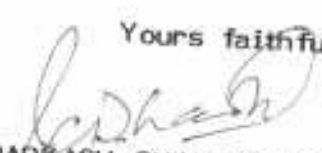
