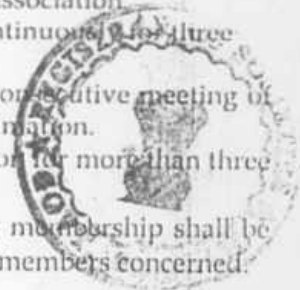
2) **SUBSCRIPTION**

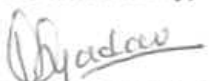
