- 5) We had submitted maps and details on 27.7.2006, on basis of which Registration No. 1472 was allotted by Urban Development Department of GNCTD. The details were pertaining to Colony 'Nawada Extension , G-Block Shyam Park. We will like to state that Nawada Extension is a huge area, having blocks from A to M. Our registration no. 1472 is existing in the list of 1539 nos. colonies list.
- 6) Details related to various actions required as per advertisement no. DIP/1455/2007-08 published on 4th Nov 2007 were submitted on 10.01.2008 and receipt no. 1355 was issued.
- 7) It has been found that an application bearing sr. no. 1373 pertaining to L-Block Nawada Extension had been received by Urban Development Deptt. in addition to our sr. no. 1355 against registration no. 1472.
- 9) It is confirmed that lay-out plans submitted are same for registration no. 1472 dated 26-7-2006 and receipt no. 1355 dated 10-1-2008.
