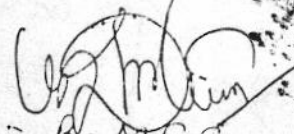

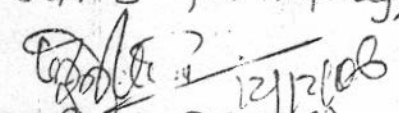

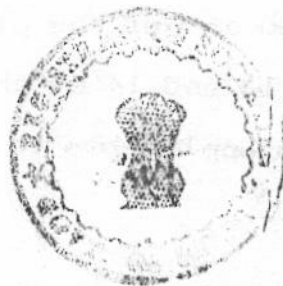

TREASURER :-

POWERS AND DUTIES OF THE OFFICE BEARERS :-

PRESIDENT :-

- a) He/she shall supervise all works and activities done by other members /office bearers of the society.
- b) He/she will be the head of the society and preside over the meeting of the General Body and the Governing body. He/she will have the rights to cast, of vote in case of tie.

VICE PRESIDENT :-

In the absence of the president, the Vice president shall use and enjoy all powers and duties which are entrusted to the president. He/she will also help and assist the president in his/her work.

GENERAL SECRETARY :-

- a) To sign and on behalf of the society conduct correspondence and to record and proceedings minutes.

- c) To call ordinary General Body meeting if desired on written request of at least 2/3rd. members of the General Body.

ASST. SECRETARY :-
