15. FILLING UP OF CASUAL VACANCIES:-

Any Casual vacancy amongst the office bearers and executive members of the Governing Body, shall be filled by the resolution passed by the Governing body. Such appointment shall be confirmed by the General body in its next General body Meeting.

16. ELECTION :-

The General body in its Annual Meeting will elect its president and all the office bearers and also the executive members of the Governing body, after every five years by secret ballot papers or by show of hands as the election officer may decide.

The election officer will be appointed by the Governing. The power of the Election officer shall also be framed by the Governing body of the society.

17. BRANCHES OR THE SUBCOMMITTEES:-

The Governing Body in its meeting shall form the Branches and/or the sub-Committees (all over India and Abroad) to attain the Aims and objects of the society.

18. ADVISORY BOARD :-

The Governing body is authorised to appoint/nominate any time the Advisory Board to solve any matter/issue. The Governing body of the society can Nominate any office bearer/executive member as the Chairman of this kind of Advisory Board.

19. SOURCES OF INCOME :-

(a) Admission fee and subscription from the members of the society.

(b) Donations and Special Contributionand

(c) Funds generated by Exhibitions, functions, seminars and other cultural programs arranged by the society.

All the income of the society (received from all sources) shall be utilised only for the promotion and upliftment of the aims and objects of the society.

B. VICE PRESIDENT :-

- (a) There shall be one vice president to assist the president of the society in his/her work.
- (b) The president may delegate all or any of his/her powers to the vice president in the event of his/her long absence.

C. GENERAL SECRETARY :-

- (a) General secretary will summon and attend the meeting of the Governing body and the General body following the directions of the president of society.
- (b) General secretary will prepare the Membership Register as well as the proceeding Register to record the minutes of the proceeding of the Governing Body Meeting and the General Body Meeting and have them duly signed by the members who attend the meeting.

D. SECRETARY :-

- (a) There shall be one secretary to assist the General Secretary of the society in his/her work.
- (b) Secretary shall enjoy all the powers of the General secretary in his/her absence.

E. JOINT SECRETARY :-

There shall be one joint secretary to help the General secretary and the secretary of the society.

F. TREASURER :-

- (a) All the assets and funds of society shall remain under the care and management of Treasurer of the society.
- (b) Treasurer shall maintain the accounts of all money which is received and/or paid by him/her on behalf of the society.
- (c) Treasurer shall make disbursements in accordance with the direction of governing body.

G. EXECUTIVE MEMBER :-

- (a) The executive member is bound to inform the society in writing if he/she is not able to attend any particular meeting of the Governing body and/or General body.
- (b) Executive Member will be terminated, if he/she has not attended three consecutive meeting of the Governing body.

12. RE-ADMISSION :-

In case any member of the society is expelled by the Governing body on the reason of Non-Payment of the subscription, he can be re-admitted provided the member concerned pays all upto date dues with the permission of the Governing body.

13. APPEALS :-

10. FUNCTIONS AND POWERS OF GOVERNING BODY :-

- (a) Governing body shall be responsible for the management and administration of all affairs of the society, and is also authorised to appoint any officebearer/executive member to look after any particular activity.
- (b) All the decision shall be taken by the majority votes.
- (c) The Governing body shall have the powers as are the powers of the society, mentioned in the Memorandum of the society and in these Rules and Regulations. The Governing Body shall have also the following powers.

(g) To appoint/terminate such staff as may be required for effective and efficient management of the affairs of the society.

(h) In the event of any office bearer(s) seat falling vacant the powers and functions of that office bearer/executive member would vest in the president of the society.

- (i) President will get the accounts of the society audited by the Qualified Auditor, appointed by the Governing body of the Society.

(a) Shall be entitled to participate in meeting cultural/ educational functions and other lawful to collect gatherings called/arranged by the society.

(b) have right the identity card after depositing the required/ prescribed fee (fixed by the Governing Body of the society from time to time)

7. DUTIES OF THE MEMBERS :-

All and every member of the society shall elect the Governing body of the society

Attend the General Body meeting regularly, give the necessary information to the society, pertaining to any matter which is necessary to be known by the society, not indulge in activities which are prejudicial to the Aims and objects and/or the Rules and Regulations of the society.

8. GENERAL BODY :-

(a) NOTICE :- Minimum '15' days notice shall be given to the member, before the date of General body meeting, enclosing agenda specifying date, Time and place and issue to be discussed.

(b) QUORUM :- The quorum of General Body Meeting shall be 2/3rd (Two third) of the total strength of the General body members of the society.

(c) MEETING :- General body Meeting shall be held once in every year regularly.

9. GOVERNING BODY :-

(a) STRENGTH :- The Strength of the Governing Body (including office bearers and executive member) shall be less than 22 and not more than 31.

(b) TERM :- The Terms of every Governing Body shall be FIVE YEAR

(c) NOTICE :- Minimum 7 days notice (or the period decided by the Governing body in Governing body Meeting called for this purpose) shall be required for the Governing Body Meeting, enclosing the agenda specifying date, time, place and the issue /topics to be discussed.

(d) Quorum :- Quorum of every Governing Body Meeting shall be 2/3rd of the total strength of the Governing Body (including office bearers and executive member)

(e) MEETING :- Governing Body Meeting shall be held once in three months (or as and when the Governing body of the society may decided from time to time.)

(f) URGENT MEETING :- The Urgent & Governing Body may be called by the 24hour notice but the quorum for the same urgent Governing meeting shall be 2/3rd of the total strength of the Governing body of the society.

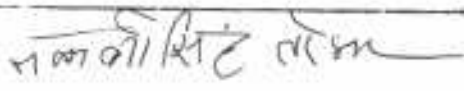
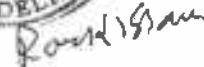
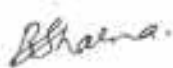

To accept donations, grants, presents, gifts, and other offering in the shape of moveable and/or immoveable properties for the attainment of the aims and objects of the society.

To purchase/acquire the land and/or the building in the name of the society for the upliftment and fulfilment of the Aims and objects of the society.

(u) To erect construct, alter, maintain, sell, lease, mortgage, transfer, improve, develop manage and control all or any part of the property or the building of the above society necessary or convenient for the purpose of the attainment of the aims and objects of the society.

(v) To do such things/acts/activities which are necessary and which may be incidental or conducive to the attainment of any of the objects of the society.

(w) All the incomes, earnings, moveable or immoveable properties of the society shall be solely utilised and applied towards the promotion of its aims and objects only as set forth in the memorandum of the society and no profit thereof shall be paid or transferred directly by way of dividends, bonus, profits, or in any manner whatsoever to the present or the past members of the society or to any person claiming through any one or more of the present or the past members. No member of the society or make any profits whatsoever by virtue of this membership.

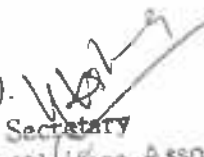
