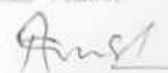

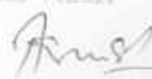

No postman comes in our area for the delivery of the letters, thus suffering a lot and most of the people in Sangam Vihar are receiving letter through the address of some other places where their relatives or friends are staying and most of such letters are being misplaced and timely attention to the contents of the letter cannot be given or taken.

In the aspect of development measure, much more thing are necessarily to be taken into consideration such as Hospital, bank, market, transport, police station, public telephone, community centres, milk booths etc. etc.

If all of these things are not possible to bring into existence immediately, atleast the importantmost amenities viz. Water, Road, Electricity, Post Office are to be given immediate preference in the stated sequence in order to spent our life as human beings in the capital of India. Sangam Vihar is in South Delhi, a noted position of the Capital and not in a remote area, which cannot be kept as rural any more, even after about 47 years of our independence.

We earnestly believe and sincerely hope that the necessary and immediate attention of the authorities will play an active and fruitful roll in the development measures of Sangam Vihar, and a powerful, benevolent and humanitarian cannot keep silent to the point brought into light while taking all the problems into consideration.

It is not out of place to mention overhere that several deaths have already been taken place in the failure of getting medical attention in time. A considerably good quantity of children are in the colonies who are refrained from going good schools due to non-availability of transportation Sangam Vihar Roads remaining guttered.

3. Electricity:

The second priority is for electricity in this area. Though this colony is in existence from 1984 onwards, there has not been provided atleast the temporary connection, may be the absence of necessary approaches and persuasion to the department concerned. In the absence of electricity one can easily imagine the situation of being still in the natural darkness.

-- Because of non-availability of electricity, all the area remains in darkness, the consequences of which are to be given utmost importance keeping in view the negative result being taken place in respect of the well being of the people.

-- The school going children cannot do their home work of maintain their studies even for examination.

-- The people are suffering drastically in the severe heat without using a fan and there are chances of deaths due to abnormal temperature.

4. School:

No good schools are there in Sangam Vihar because of which we cannot get our children education in a better manner, which results into keeping the future of the growing children into an entirely backward.

are being made from the colony for the remedy of the pump's malady. But somebody co-operates and somebody not - mainly due to their inability to spare regularly for the rectification of pumps. Somehow or the other, the organisers of the association and some broad-minded members are contributing the shortfalled amount to make the pump alright in order to effect some sort of relief to the urgently needed item. In the event of getting our pump damaged, all the people will move towards the next hand pump installed, which will also get damaged immediately due to heavy load and hence the problem doubling, tripling and multiplying accordingly, and thus, we have to suffer miles together for little drinking water, which is very horrible mainly to house wives who have to take along with their children also, to such a long distance and time and then to carry the ~~xxx~~ fetched water and the child together. Due to shortage of water, the drinking purpose is not being served and, then what about the bathing and washing purpose; thereby inviting all reasonable and unreasonable diseases on account of dirtiness as a whole.

2. Road - 2nd priority:

The main road (Gill Farm Road) is full of gutters, due to which, as on date, several incidents of accidents and deaths have already taken place. While passing the trucks, the pedestainers or cyclists are not fully aware about the alignment balancing of the wheel of the loaded truck, and when it enter into a gutter, loses the balance, which results into accidents. Since the condition of the road is very bad, we cannot enjoy the facility of atleast a three-wheeler conveyance incase of emergency and nobody turns while hearing the name of Sangam Vihar.

plot of land to provide shelter to themselves and their family in order to be away from the stated problems. More than 75% of the people staying in Sangam Vihar are below poverty line and the others are economically weaker section, who are still facing numerous problems to feed their families in the troublesome situation of not being water, convenient road, electricity, hospital, school, street light, roads, conveyance, market, post office, public parks, milk booths, community centres etc.

The main problem is water:

As you will agree that for a living creature, the first important item is water while treating the air easily available naturally, particularly in G-II Block of Sangam Vihar, there is only one hand pump which is being mobilised around the clock while providing drinking water not only to the residents of G-II Block, but also to the surrounding areas. A person who want to have a bucket of water, has to spent hours together in the queue to come his turn, the quantity of fetched water is equal to nil in comparison to the consumption of water in a house by way of cooking, washing, bathing etc. Long and long waiting in the queue to fetch the water, becomes risk due to people loosing patience while afraid about their loosing employment while arriving late in their working places, and more over there are chances of abuses and attacks etc. if somebody takes their turn before it comes.

While keeping the pump in exercise continuously around the clock, it starts malfunctioning 'off & on', for the repair of which considerably a large sum is required beyond the normal capacity of the residents. Hence, some collections

Though the Association started functioning years back, we could have the opportunity to get it registered recently only i.e. on 21/3/89

We would like to highlight you beleneath the hardships being suffered by the residents for quite considerable years together say from 1984 onwards, who have established their shelters in this locality; the reason being many:

- a) Harrasment/Disturbances created by the landlords,
- b) Non-availability of residential rooms at reasonable rates due to conversion of residential colonies into partially commercial purpose,
- c) Exorbitant rent rates in the regularised colonies,
- d) Rent being charged on 'per head' basis,
- e) Restrictions on Electricity & water consumption,
- f) Restrictions on guest/relative visit,
- g) Limitations on occupying period etc..etc.

As a whole, it is not at all possible for an average person to spent their life while paying rent who has simultaneously to look after their families with the meagre income out of their daily earnings. Most of the present residents have sold their properties in their native places or sold their ornaments or mortgaged them on high interest for the purpose of purchasing a small

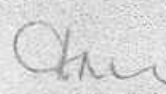

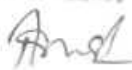

5. POST OFFICE:

No postal distribution arrangements are there in Sangam Vihar, and therefore, we cannot even sent or receive letters through the proper channel. No postman comes in our area for the delivery of the letters, thus suffering a lot and most of the people in Sangam Vihar are receiving letter through the address of some other places where their relatives or friends are staying and most of such letters are being misplaced and timely attention to the contents of the letter cannot be given or taken.

In the aspect of development measure, much more thing are necessarily to be taken into consideration wuch as Hospital, bank, market, transport, police station, public telephone, community centres, milk booths etc. etc.

If all of these things are not possible to bring into existence immediately, atleast the importantmost amenities viz. Water, Road, Electricity, Post Office are to be given immediate preference in the stated sequence in order to spent our life as suman beings in the capital of India. Sangam vihar is in South Delhi, a noted position of the Capital and not in a remote area, which cannot be kept as rural any more, even after about 47 years of our independence.

We earnestly believe and sincerely hope that the necessary and immediate attention of the authorities will play an active and fruitful roll in the development measures of Sangam Vihar, and a powerful, benevolent and humanitarian cannot keep silent to the point brought into light while taking all the problems into consideration.

It is not out of place to mention overhere that several deaths have already been taken place in the failure of getting medical attention in time. A considerably good quantity of children are in the colonies who are refrained from going good schools due to non-availability of transportation Sangam Vihar Roads remaining guttered.

3. Electricity:

The second priority is for electricity in this area. Though this colony is in existence from 1984 onwards, there has not been provided atleast the temporary connection, may be the absence of necessary approaches and persuasion to the department concerned. In the absence of electricity one can easily imagine the situation of being still in the natural darkness.

-- Because of non-availability of electricity, all the area remains in darkness, the consequences of which are to be given utmost importance keeping in view the negative result being taken place in respect of the well being of the people.

-- The school going children cannot do their home work of maintain their studies even for examination.

-- The people are suffering drastically in the severe heat without using a fan and there are chances of deaths due to abnormal temperature.

4. School:

No good schools are there in Sangam Vihar because of which we cannot get our children education in a better manner, which results into keeping the future of the growing children into an entirely backward.

are being made from the colony for the remedy of the pump's malady. But somebody co-operates and somebody not - mainly due to their inability to spare regularly for the rectification of pumps. Somehow or the other, the organisers of the association and some broad-minded members are contributing the shortfalled amount to make the pump alright in order to effect some sort of relief to the urgently needed item. In the event of getting our pump damaged, all the people will move towards the next hand pump installed, which will also get damaged immediately due to heavy load and hence the problem doubling, tripling and multiplying accordingly, and thus, we have to suffer miles together for little drinking water, which is very horrible mainly to house wives who have to take along with their children also, to such a long distance and time and then to carry the ~~xxx~~ fetched water and the child together. Due to shortage of water, the drinking purpose is not being served and, then what about the bathing and washing purpose; thereby inviting all reasonable and unreasonable diseases on account of dirtiness as a whole.

2. Road - 2nd priority:

The main road (Gill Farm Road) is full of gutters, due to which, as on date, several incidents of accidents and deaths have already taken place. While passing the trucks, the pedestrainers or cyclists are not fully aware about the alignment balancing of the wheel of the loaded truck, and when it enter into a gutter, looses the balance, which results into accidents. Since the condition of the road is very bad, we cannot enjoy the facility of atleast a three-wheeler conveyance incase of emergency and nobody turns while hearing the name of Sangam Vihar.

plot of land to provide shelter to themselves and their family in order to be away from the stated problems. More than 75% of the people staying in Sangam Vihar are below poverty line and the others are economically weaker section, who are still facing numerous problems to feed their families in the troublesome situation of not being water, convenient road, electricity, hospital, school, street light, roads, conveyance, market, post office, public parks, milk booths, community centres etc.

The main problem is water:

As you will agree that for a living creature, the first important item is water while treating the air easily available naturally, particularly in G-II Block of Sangam Vihar, there is only one hand pump which is being mobilised around the clock while providing drinking water not only to the residents of G-II Block, but also to the surrounding areas. A person who want to have a bucket of water, has to spent hours together in the queue to come his turn, the quantity of fetched water is equal to nil in comparision to the consumption of water in a house by way of cooking, washing, bathing etc. Long and long waiting in the queue to fetch the water, becomes risk due to people loosing patience while afraid about their loosing employment while arriving late in their working places, and more over there are chances of abuses and attacks etc. if somebody takes their turn before it comes.

While keeping the pump in exercise continuously around the clock, it starts malfunctioning 'off & on', for the repair of which considerably a large sum is required beyond the normal capacity of the residents. Hence, some collections

Though the Association started functioning years back, we could have the opportunity to get it registered recently only i.e. on 21/3/89

We would like to highlight you beleneath the hardships being suffered by the residents for quite considerable years together say from 1984 onwards, who have established their shelters in this locality; the reason being many:

- a) Harrasment/Disturbances created by the landlords;
- b) Non-availability of residential rooms at reasonable rates due to conversion of residential colonies into partially commercial purpose,
- c) Exorbitant rent rates in the regularised colonies;
- d) Rent being charged on 'per head' basis,
- e) Restrictions on Electricity & water consumption,
- f) Restrictions on guest/relative visit,
- g) Limitations on occupying period etc..etc.

As a whole, it is not at all possible for an average person to spent their life while paying rent who has simultaneously to look after their families with the meagre income out of their daily earnings. Most of the present residents have sold their properties in their native places or sold their ornaments or mortgaged them on high interest for the purpose of purchasing a small
