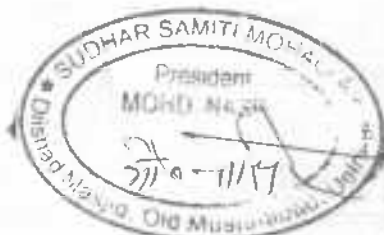

10. Governing Body
