This is to bring to your notice for intervention the following:

1. Shri. Jagdish Chand, R/o 13-A, Village Meethapur, Delhi 110044 is Secretary of the South Delhi District Committee of the CPI (M). He had met you in November, 2008 and submitted a written complaint against attempts of Shri Mahesh Awana, Municipal Councillor from Ward No. 202 (Meethapur) to illegally convert agricultural land owned by him into a residential colony. Subsequently, these illegal activities were stopped.

2. Since then, Shri Awana has been trying to harass Shri. Jagdish Chand and his family. Unfortunately, the SDM, Kalkaji have become party to these moves. This is evident from the following facts outlined by Shri. Jagdish Chand in his letter to you dated 26 March, 2006:

i). Shri. Jagdish Chand's wife, Smt. Kiran had purchased Plot No. 39, in Khasra No. 887 (1-14), Village Molarband, New Delhi in 1989. A house was constructed on this plot in the same year. The colony where this plot is located is popularly known as Shakti Vihar. The latter finds mention in the list of 1071 unauthorized colonies referred for regularization by the Delhi Government to the Centre.

ii). In late 2008, the Delhi Government raised the level of the road on which this house is located. As a result those along this were compelled to undertake renovation for raising the level of their houses to avoid water logging.

iii). On 9 February the local police handed a notice to Smt. Kiran from the SDM, Kalkaji charging her misusing agricultural land for residential purposes and ordering halt to the renovation of her house.

iv). No one else located in Khasra No. 887 (1-14), Village Molarband was issued any such notice, either for construction activities or for operating commercial establishments from there.
