But no development works in our colony, namely, Shri Hans Nagar Colony, Pandwan Kalan, Ghumanhera Road, Najafgarh (regd. at Sl.No.0199) have yet been started inspite of our persistent persuasions for one reason or the other. Sometime it is reported that land status report is yet to come ; sometime it is reported that funds have exhausted ; sometime it is reported that Election Code is in force ; now it is being reported that because in our colony there exist two Associations, therefore, the works cannot be started and GNCTD have referred the matter to the Ministry of Urban Development and till the final decision is taken we will have to wait.

Sir, can we know the fate of these poor residents who have been living in this colony for the last 22 years and waiting for provision of basic infrastructure facilities and waiting for regularization since long. Our residents were very happy when they received a copy of the Provisional Regularisation Certificate and hoped that now those bad days would now be over and Govt. of National Capital Territory of Delhi would start the development works soon in our colony soon.

Sir when our colony qualifies all the conditions of regularization as announced by the GNCTD and has submitted the proof of more than 75% residents with us, to MCD & GNCTD, then as to why GNCTD cannot start development works in our colony.

Since our colony is the oldest colony and has been waiting for start of development works since long, the residents of our colony shall feel highly obliged if the development works are started in our colony at the earliest please. In this connection, we had requested previous Hon'ble UD Minister, GNCTD also for carrying out development works through DSDIC.


