- 12. That Shri Bharat Singh was invited by this applicant Association in the General Body Meeting held on 1.2.2009 at 9.00 P.M. at Sanidev Mandir Committee Hall. He was requested to inform about the schemes being projected and implemented in our area ('C' Block) and also to apprise the members of the actions being pursued by him with various government and private civic agencies responsible for community development/welfare activities. But, he had refused to share the information among the members and said that he would not give anything in writing to incorporate the name of this applicant Association in the certificated dated 17.9.2008 (Annex:IV-A); he did not turn up in the meeting too.
- 13. That all the developmental schemes are being cornered by Shri Bharat Singh and are being diverted to 'A' and 'B' Block at the cost of the member-families living in 'C' Block, Hind Vihar. Due to this, identity crisis, in the absence of a separate Provisional Certificate of Regularisation, the people residing in 'C' Block are feeling great unrest and there is general feeling of anguish[helplessness among the people.

GROUNDS:-
