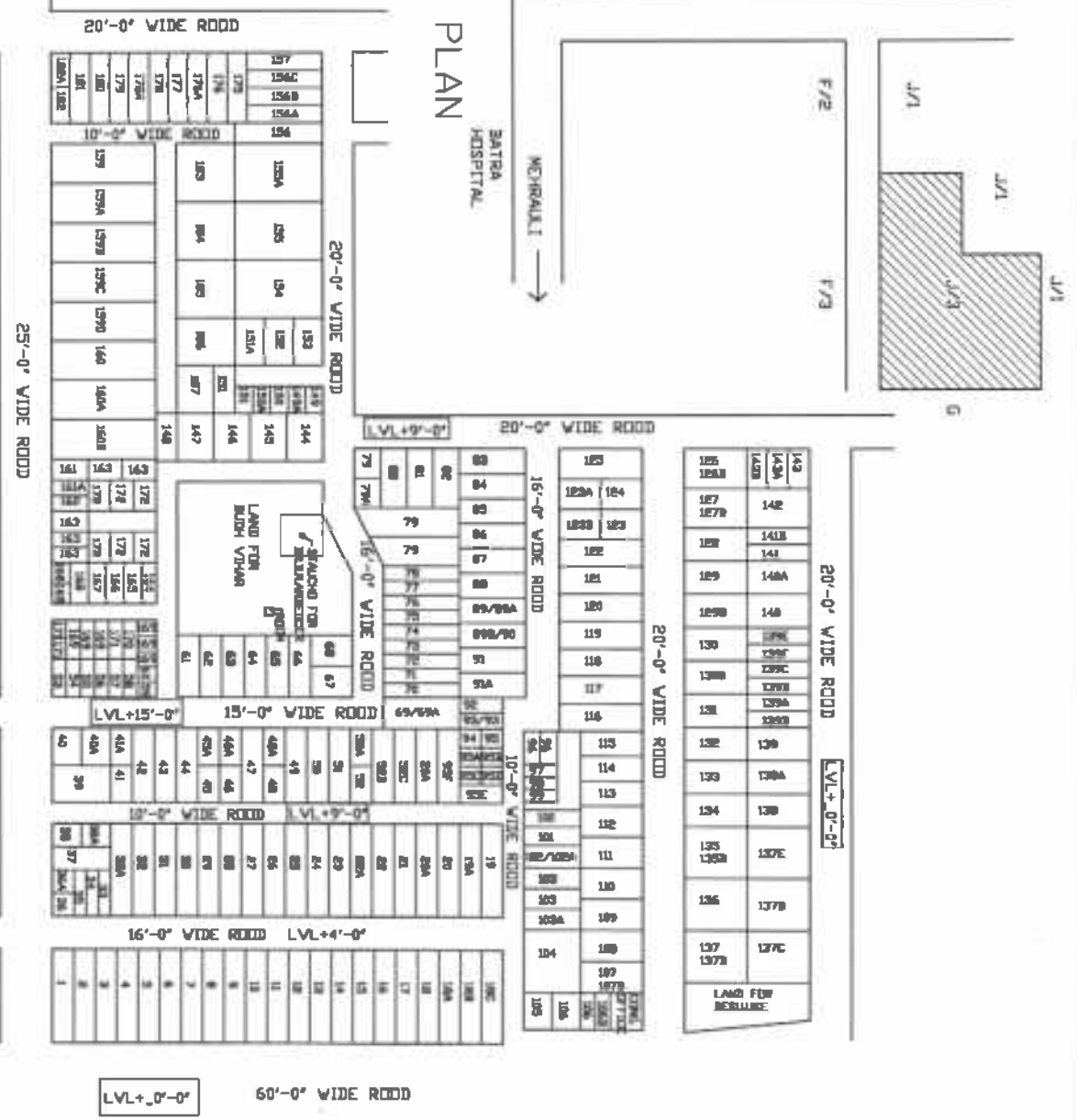

Sir,

On the subject cited above, I am directed to inform you that initially the list of 1432 unauthorised colonies was received from GNCTD, out of which Land Management Branch, DDA sorted out 228 unauthorised colonies which are falling in the Development Area of DDA and the Built up percentage of these 228 unauthorised colonies as on 31.3.2002 were sent to GNCTD. At a later stage another list of 88 unauthorised colonies was sent by GNCTD for the consideration of regularisation. Now the total no. stands at 1432 + 88 = 1520 unauthorised colonies. Out of these 88 unauthorised colonies, only 3 colonies were found to be falling in the Development Area of DDA of which the report of Built up percentage has been prepared and enclosed herewith. With this the built up percentage of all the 231 unauthorised colonies has been provided to GNCTD.

In addition to this, as per the Guidelines dated 10.02.2004 issued by MOUD, a list was prepared by collecting the information from all the concerned Director (Planning) DDA regarding the unauthorised colonies which are posing hinderances to the infrastructure. The list of these 191 unauthorised colonies (falling in Dev. Area of DDA & colonies falling in Regional Park) is also enclosed which was presented earlier in one of the meetings.
