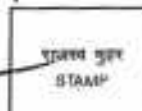

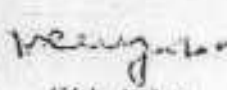

On 22.10.2004, the Government has issued a public notice requiring residents of unauthorised colonies to submit an application as per proforma. The Resident Welfare Association/Co-operative Society of the residents has to enclose a site plan as also list of property owners giving all particulars. Existing facilities etc have to be indicated. Requisite applications have to be submitted on or before 30.12.2004.

When similar kind of grievance was made in an earlier proceeding vide order dated 17.8.98 in W.P(C)4771/03, a Division Bench of this Court held that if a particular colony has not to be regularised, all buildings should be demolished and not merely demolition of a few selected houses. From time to time, petitions were filed in this Court making similar grievance and at each time, this Court had to intervene by reminding the authorities not to resort to pick and choose.

5. Since latest guidelines have been framed by the Government and a public notice has been issued on 22.10.2004 requiring the residents to form Residents Welfare Associations or Co-operative Societies, which bodies in turn have to submit the necessary applications, undertakings and documents by 30.12.2004, present petitions are disposed of with a direction to

1. The three captioned petitions pertain to buildings belonging to the petitioners in village Karkardooma. Case of the petitioners is that the extended abadi of this village is one out of 1071 unauthorised colonies proposed to be regularised by the Government. It is stated that the Government is committed to regularise all unauthorised colonies which have come up in Delhi prior to April 2002. Grievance made is that officers of respondents are resorting to pick and choose policy by demolishing houses at their whims and fancies.

2. Revised guidelines pertaining to regularisation of unauthorised colonies in Delhi were circulated by the Government of India on 10.2.2004. The guidelines, amongst others, envisaged residents of unauthorised colonies to form registered co-operative societies or welfare associations, which in turn were to interact with the government agencies. The guidelines required the Residents Welfare Association/Co-operative Societies to submit certain undertakings as also to

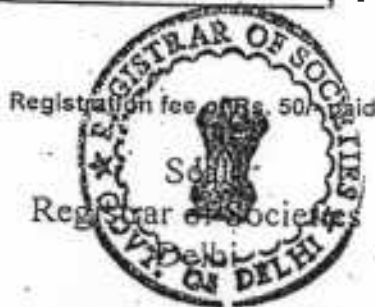

3. On 22.10.2004, the Government has issued a public notice requiring residents of unauthorised colonies to submit an application as per proforma. The Resident Welfare Association/Co-operative Society of the residents has to enclose a site plan as also list of property owners giving all particulars. Existing facilities etc have to be indicated. 4. 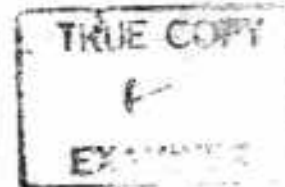

10. In view of the foregoing discussion, the petitions are disposed off with a direction to the respondents to take action in terms of the policy guidelines, issued on 10.2.2004, and process the application of the petitioners for regularization, if the same has been filed, as per averments in the petition. 9. I have carefully considered the pleadings and submissions of parties. There is no dispute about the fact that the village in question is one of the 1071 unauthorized colonies which is awaiting regularization. There is also no dispute that in respect of the village, Karkardooma, this court had made directions in WP 1538-39/04 and connected cases. The only issue is whether the petitioners have made out a case for similar treatment, particularly in view of the allegations of the respondents about the use of the premises not being residential, but commercial.

The petitioners have contested the stand of the respondent, in their rejoinder affidavit, and contended that they are using the premises for residential purposes.

In my opinion, the matter can be resolved by directing the DDA to carry out an inspection, and at the same time requiring the petitioners to file an affidavit to the effect that they would not be using their premises for commercial purposes. The order passed in relation to the village, subject to this modification can be extended in this case as well.

He has placed reliance upon condition No. 1.1 of the Revised Guidelines for Regularization issued on 10-2-2004, particularly sub-clause (d) which reads as

4. Learned counsel for the petitioner submits that the fifth respondent is an RWA, which had made an application to the second respondent, on 24th December, 2004. A copy of the application has been produced, as Annexure P-7 (Collectively). It is submitted that in terms of the guidelines the petitioners' premises qualify for regularization; all of them are using their buildings for residential purposes.

5. Reliance has been placed upon the decision of a Division Bench of this Court, in W.P(C)4771/03, where, by its order dated 17.8.98, it was held that if a particular colony has not to be regularised, all buildings should be demolished and not merely demolition of a few selected houses. It is also submitted that the authorities cannot resort to a policy of selectively picking and choosing certain premises, without proceeding in a uniform manner. Counsel for the petitioner also relies upon a decision of the court, pertaining to the same area, which had noticed the existence of the guidelines, and granted relief. In that decision, rendered in a batch of petitions (WP 1538-39/2004 and connected cases), the Court, after noticing all the above developments, directed as follows:

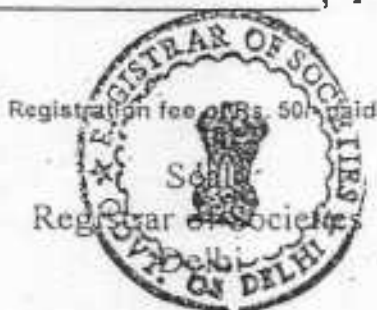

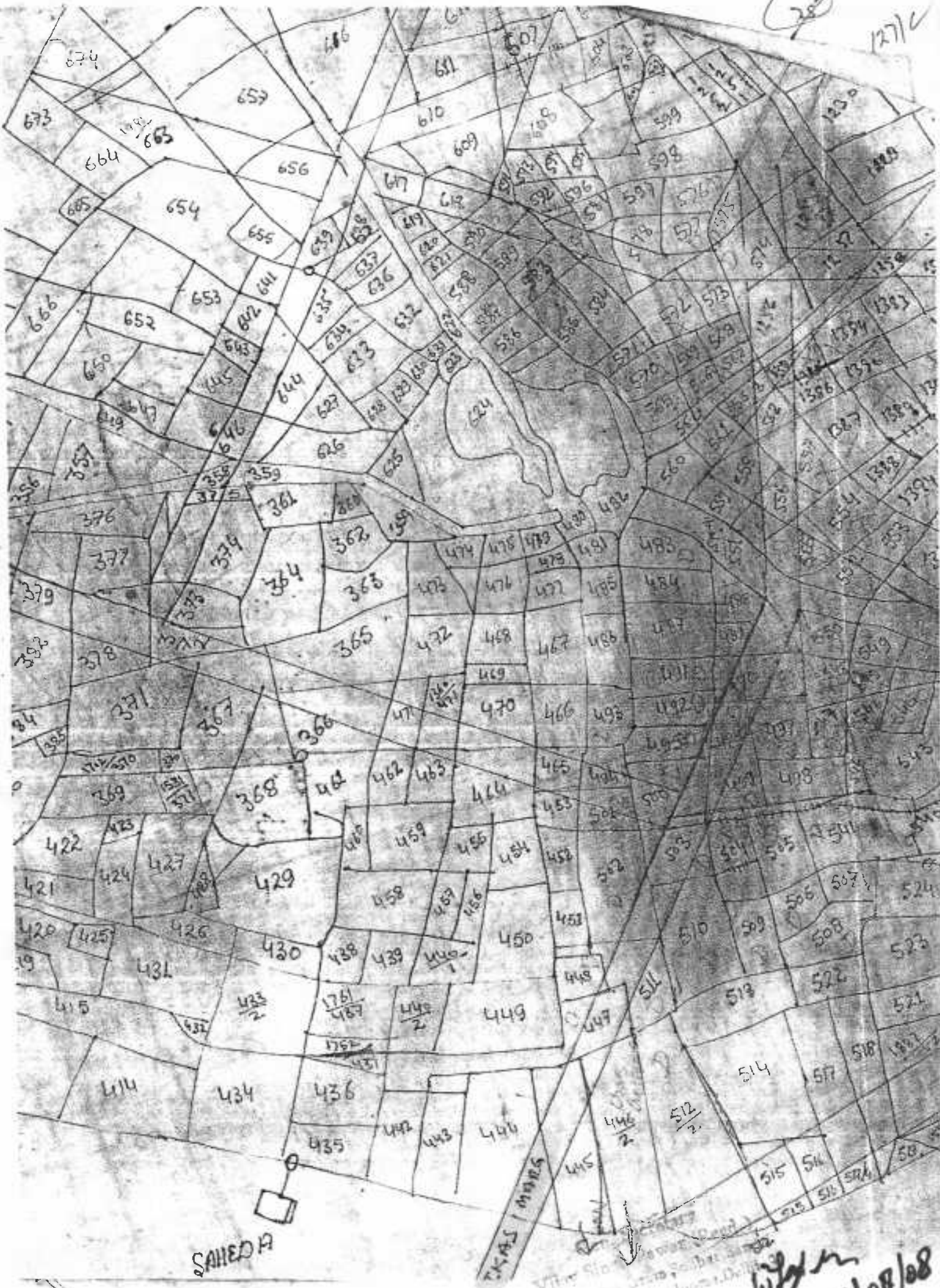
