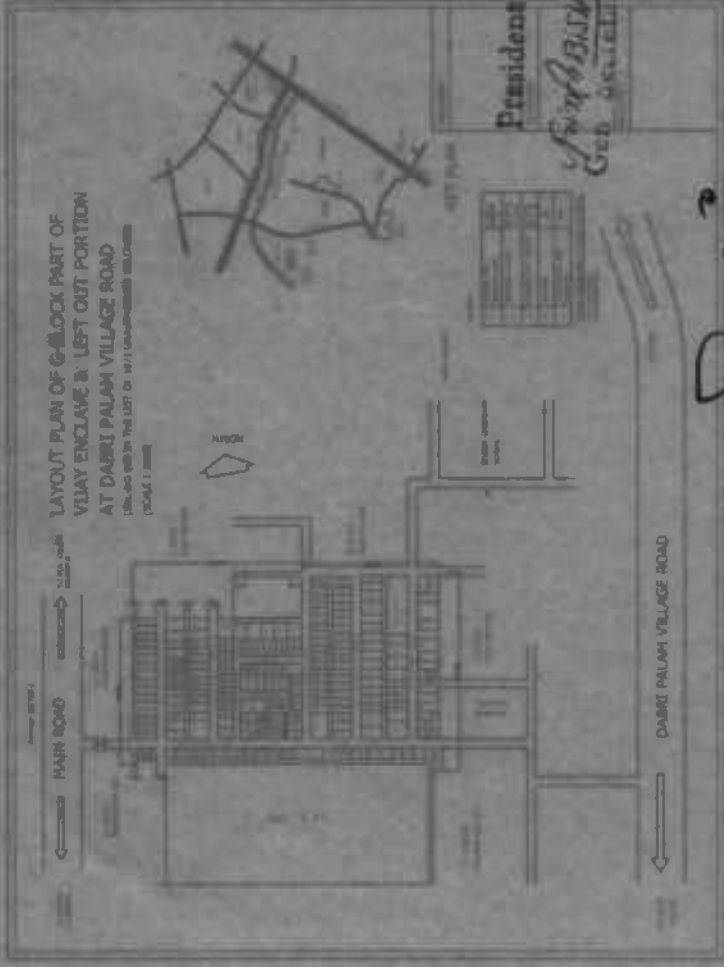

(SCALE 1:1000)

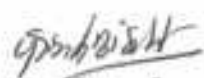
