Subject: Request for carry out development work in the extended abadi area of Village Dallupura Included in the list of 1071 & 1432 unauthorised colonies namely 'Dallupura Extended Abadi.'

Respected Sir,

I am to say that Dallupura is a historical village which is about more than 400 years old. The 'Lal Dora' of this Village has not been extended since 1908 whereas the population has increased many folds during the last 100 years. As Central Govt./Delhi Govt. had/has no policy to regularize the extended abadi area of such Villages, we had/have no option but to apply for regularization of extended abadi area of Village Dallupura under the scheme of regularization of unauthorised colonies. Now 'Dallupura Extended Abadi' is included in the list of 1071 (Sl. No. 120) and 1432 (Sl. No. 205 and application receipt No. 348) unauthorised colonies which were in existence on 31.3.1993 and 31.3.2002 respectively.

The sanitary condition of 'Dallupura Extended Abadi' area is very bad. There is no drainage system. The dirty water and rainy water is stagnated in the open area which is the main cause of spreading of mosquitoes and other water born deceases. The stagnated dirty water has also spoiled ground water. The residents of this area are void of basic facilities.

It is therefore requested that basic development work may please be got carried out in the Dallupura Extended Abadi area so that sanitary condition of this area may be improved. We shall be highly obliged for the same.
