All the appeals should be referred to the General Body of the Society. The decision of the General Body shall be final. The reason for objection shall be communicated to the member concerned.



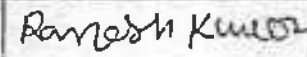
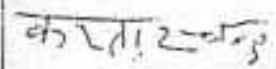
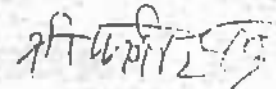
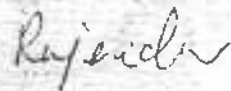
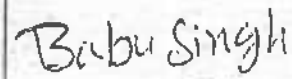
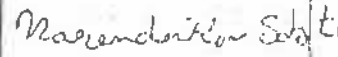
