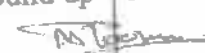

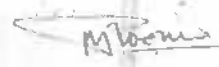

11. **SOURCE OF INCOME AND UTILIZATION :-** The subscription, grants-in-aid and gifts from the members and the general public shall be the source of income of the society. All the income of the society shall be utilized towards the aims and objects of the society.

12. **FINANCIAL YEAR :-** The Financial year of the society shall be from 1st April to 31st March every year.

13. **AUDIT OF THE FUND'S ACCOUNT :-** Treasurer of the society shall get audit the fund of society annually by the qualified auditor appointed by the governing body and approved by the general body. All the members of the working committee will assist to the treasurer to this deed.

14. **BANK ACCOUNT OPERATION :-** The fund of the society shall be deposited in the nearest scheduled (nationalized) bank. The bank account of the society shall be operated by the treasurer and any one of the president or secretary. The role of treasurer shall be centralized.

15. **ANNUAL LIST OF GOVERNING BODY (Section 4 of Act)**

16. **LEGAL PROCEEDINGS (Section 6 of Act) :-** The society may sue or be sued in the name of the president / secretary as per provisions laid down under section (6) of the societies registration act 1860 as applicable in the union territory of Delhi.

(2) Vice-President :- In the absence of the president the vice-president shall enjoy all the powers and duties which are entrusted to the president. He will also assist to the president in his works.

(3) Secretary :-

- (a) He shall represent the society in all public and private offices.
- (b) He shall keep all types of record of society including the members containing their names, addresses and other brief particulars.
- (c) He shall undertake all types of correspondences on behalf of the society.
- (d) He shall convene the meeting of general body and governing body. He shall also inform every member regarding time, date and the place of the meeting through a seven days earlier written notice.

(4) Deputy-Secretary :- In the absence of secretary the deputy-secretary shall enjoy all powers and duties which are entrusted to the secretary. He will also assist to the secretary in his work.

(5) Treasurer :- He shall collect subscriptions, gifts, grant-in-aid and donation from the members and the general public and he shall also be responsible for keeping and maintenance of a true and correct accounts of the society. He shall also get audit the fund of society annually from an auditor approved by the general body.

(6) Executive members :- All the executive members will assist the bearers in their works as directed by the president or secretary of the society.

10. THE STRUCTURE OF SUB COMMITTEE (SANCHALAN SAMITI)

(A) STRUCTURE :- There shall be a either 3 or 5 members sub committee namely Sanchalan Samiti to monitor and advise the governing body.

(B) MODE OF CONSTITUTION :- The newly elected working committee will nominate its either three or five members of sanchalan samiti (sub committee). The tenure of sanchalan smiti (sub committee) would be one year. A new working committee is elected after the completion of tenure of previous working committee. After that the sanchalan samiti (sub committee) would be considered dissolved it self. The new sanchalan samiti (sub committee) would be nominated by the freshly elected working committee.

(C) RIGHTS AND DUTIES OF THE SANCHALAN SAMITI :-

Sanchalan samiti shall assist and advise the working committee for execution of its programme and policies. They will analyze them also. Sanchalan Samiti members are also entitled to vote on any proposal or policy raised in combined meeting of working committee and sanchalan samiti.

(11) THE MODE OF EXECUTION OF FUNCTIONS OF THE GOVERNING BODY:-

(A) There would be a brief discussion of all the programme and policies under the rules and regulations of the memorandum of the society. The proposal / policy can be passed only after the approval of minimum half and one more present members in the meeting of the working committee.

(B) The president can vote in favor of any proposal / policy only meanwhile the votes are found 50-50 (on equality).

(C) No quorum is required in the collection of unanimous (no objection).

(D) All the policies / proposal passed under the provisions of A, B and C will be forwarded for the analysis in sanchalan samiti and such can be executed only after the approval by the sanchalan samiti with the quorum of half and one more present members with no objection quorum.

(E) If the sanchalan samiti returns any such proposal/policy without passing the same, for reconstruction to the working committee. The working committee will make either necessary amendment or no amendment and send it to the sanchalan samiti. If again sanchalan samiti don't give its approval then the president will call the combined meeting of sanchalan samiti and working committee. In such meeting those policy / proposals would be considered passed only after the approval of 2/3 or 60% quorum of the present member in the meeting.

(F) Only the members who will give their approval to any such policy / proposal would be responsible for its good and bad effects.

(G) **INTERVAL AND NOTICE FOR THE MEETING:-** One meeting Working committee is compulsory to be held in every month. The emergency meeting of the working committee can be called on the written request of the 3/5 or 60% members of the either working committee or general body giving three days prior written notice to the working committee.

(H) **QUORUM OF THE MEETING :-** The meeting of the working committee shall be held with 3/5 or 60% quorum. No quorum shall be required for dissolved meeting.

(I) **FILLING OF CASUAL VACANCIES :-** The casual vacancies shall be filled up by the resolution passed by majority of vote by both governing body and general body.

(J) OFFICE BEARER AND THEIR DUTIES:-

(1) **President :-** He will preside over all the meeting of governing body and general body. He has right to cast his vote only in case of the equality of votes on any proposal/policy in any meeting. He may examine/supervise the works of all other office bearer from time to time.

(f) If in any meeting of governing body, any member of the working committee, raise no confidence proposal and the same passes by the approval of 2/3 i.e. 7/11 members of the working committee meeting then the working committee would be considered in minority and in that condition the sanchalan samiti have the right to acquire all the rights and property of the governing body but such type of proposal (no confidence proposal) can be raised only after giving seven days prior written notice to the governing body.

(E) **TENURE OF THE WORKING COMMITTEE :-** The tenure of the governing body of the Resident's Welfare Association shall be only for two years and the same may be applicable just after the declaration of the result of the election by the election committee in general body meeting.

(F) **RIGHTS AND DUTIES OF THE MEMBER OF WORKING COMMITTEE :-** The following business shall be transacted in the meetings of governing body -

- (1) To take necessary steps for the implementation of the programme and policies, announced in the general body.
- (2) To pass the necessary expenditure to meet the day requirement of the society.
- (3) To take decision on applications for membership.
- (4) To nominate minimum 3 or maximum 5 members of sanchalan samiti that will monitor, help and advise to working committee.
- (5) To arrange finance if required from other bank(s) institution or individual on reasonable terms and conditions and the governing body as a whole is liable for its return.
- (6) To appoint, terminate and fix duties of any member of the society.
- (7) To sue and defend all legal proceedings on behalf of the society.
- (8) To appoint receiver to have in custody of and to expend the fund of association and to manage the properties of the association/society.
- (9) To take all such other legal steps which may appear beneficial for the smooth and better management of the society and its development.

(D) QUORUM OF THE GENERAL BODY MEETING: - The General Body meeting shall be held necessary with 2/3 or 60% quorum.

WORKING COMMITTEE :-

(A) STRUCTURE :- There shall be a working committee of the governing body to execute the day to day works of the society. It shall be elected by in the general body only.

In the meantime, if sanchalan samiti requires to extend the time of election, it shall take necessary approval by the general body within one month.

(c) In condition of no objection during the complete process of election must be conducted in general body and necessary. No hand raising mode shall be accepted at any circumstance and any member of the society shall have a right to contest for the post of president of the society.

(d) All the members of working committee (minimum 8 maximum 15) shall be elected in general body only.

(e) The candidate for the post of president shall have to make declaration of his assisting members (vice-president, secretary, deputy-secretary and treasurer) in his manifesto while filling the nomination form. The manifesto should be abiding to the rules and regulations of the society as mentioned in the memorandum. The written

6. APPEAL AND RE-ADMISSION:-

(A) Every expelled member shall have the right to appeal before the general body which may or may not be accepted.

(B) All the appeal shall be preferred to the general body of the society. The decision of the general body shall be final. The reason for rejection shall be communicated to the member concerned.

1. **NAME OF THE SOCIETY :-** The name of the society shall be "A' BLOCK, SHASTRI PARK, Resident's Welfare Association" *BURARI, DELHI.*
2. **MEMBERSHIP :-** Only the residents of A block Shastri Park, Burari Delhi-84, having no outstanding dues, but abide by the terms and conditions of the society, shall be considered as members of the society.
3. **ELIGIBILITY FOR THE MEMBERSHIP :-** The membership of the society is open only for:- (A) The residents and shopkeepers of A-block, Shastri Park, residing with their family in his own occupied house and having age of majority and are abide by the terms and conditions of the society. (B) Those who requests for membership without discrimination of religion, cast, colour or creed but subject to the approval of the governing body.
4. **SUBSCRIPTION :-** The rate of subscription for all the members shall be Rs. 60/- half yearly or Rs. 120/- annually and Rs. 20/- for admission. Lifetime membership shall be Rs. 1000/- once. All types of subscriptions be paid in advance and would not be refundable.

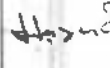

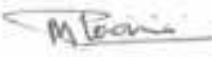

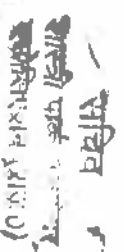

20. AMENDMENT (Section 12 & 12A of the Act)

Any amendment in the memorandum or rules will be carried out in accordance with procedure laid down under section 12 & 12A, of Societies registration Act, 1860.

21. DISSOLUTION AND ADJUSTMENT OF AFFAIRS (Section 13 & 14 of Act)

If the society need to be dissolved, it shall be dissolved as per provision laid down under section 13 and 14 of the Societies registration Act, 1860, as applicable to the Union Territory of Delhi.

22. APPLICATION OF THE ACT:-

All the provision under all the sections of the societies registration Act, 1860, as applicable to the Union Territory of Delhi shall apply to the society.

vi. EXECUTIVE MEMBERS:-

They shall assist in the day to day work of the society as directed by the president and General Secretary.

12. REGISTER OF MEMBERS:-

The society shall maintain at its registered office a register of its members and shall enter there in within 15 days after admission of member or the cessation of his membership as the case may be following particulars:-

- a. The name and address of the members.
- b. The date on which the member was admitted.
- c. The date on which a member ceased to be such member.

13. FINANCIAL YEAR:-

The financial year of the society shall be from 1st April to 31st March every year.

14. SOURCE OF INCOME AND UTILISATION:-

Subscriptions, donations, grants-in aid and gifts, from the members and the general public shall be the source of income of the society. All the income of the society shall be utilised towards the aims and objects of the society.

15. BANK ACCOUNT OPERATION:-

The funds of the society shall be kept in a Scheduled Bank. The bank account of the society shall be operated by the Treasurer and any one of the president or general secretary. The account shall be audited by qualified auditor every year.

16. FILLING UP CASUAL VACANCIES.

The Casual vacancies may be filled up by the resolution passed by majority of vote by both the governing body and general body.

11. OFFICE BEARERS & THEIR DUTIES:-

- i. PRESIDENT:-** A. He shall preside overall the meetings of general body and governing body.
B. In case of equality of votes in any meeting he shall tender his casting vote.
C. He shall supervise work of other office bearers from time to time.

ii. VICE- PRESIDENT:- In the absence of the president the vice-PRESIDENT shall enjoy all powers and duties which are entrusted to the president. He will also assist to the president in his work.

- v. TREASURER:-** He shall collect subscription, gifts, grants-in-aid and donations from the members and the general public and he shall also be responsible for keeping and maintenance of a true and correct accounts of the society's funds.

10. GOVERNING BODY:- There shall be a governing body of the society to look after and manage the day to day affairs of the society. It shall consist of minimum 8 and maximum 15 members including the office bearers. The meetings of the governing body shall be held after every two months with 1/3 quorum. No quorum required in the adjourned meeting. An Emergent meeting of the governing body may also be summoned on the written request of 3/5 members by 10 day notice of the meeting. The notice period of the governing body shall be 10 days. The following business shall be transacted in the meeting:-

- a. To take necessary steps for the implementation of all the programmes and policies drawn by the general body.
- b. To pass the necessary expenditure to meet the day to day requirements of the society.
- c. To take decisions on applications for membership.
- d. To appoint committee for disposal of any business of the association or for advice in any matter pertaining to the association.
- e. To arrange finance if required from other bank(s) Institution or individual on reasonable terms and conditions and the governing body as a whole is liable for its return.
- f. To appoint, terminate and fix duties of any staff.
- g. To appoint, receive, to have custody of and to expend the funds of association and to manage the properties of the association.
- h. To sue and defend all legal proceedings on behalf of the society.
- i. To take all such other legal steps which may appear beneficial for the smooth and better management of society.
- j. The following is the present structure of the governing body:-
 - i. PRESIDENT.....ONE.
 - ii. VICE-PRESIDENT.....ONE.
 - iii. GENERAL SECRETARY..one.
 - iv. SECRETARY.....ONE.
 - v. TREASURER.....ONE.
 - vi. Executive member ...Minimum 3 and maximum 15.

6. APPEALS:-

All the appeals shall be preferred to the general body of the society, the decision of the general body shall be final. The reason for rejection shall be communicated to the member concerned.

7. RE-ADMISSION:-

In case of member expelled by the general body the same can be readmitted provided the member concerned pays all upto date dues. The decision of the General body shall be final.

8. RIGHTS & PRIVILEGE OF MEMBERS:-

Every member shall have rights to participate in the General body meeting and shall also be entitled to inspect the record of the association with prior approval of governing body. Besides this he/she shall have also right to vote in the meetings of the association. Every member shall be entitled to participate in the meetings, functions and get-together programmes of the society. To inform the society pertaining to any matter of the society.
